

NOTICE OF HUNT COUNTY COMMISSIONERS COURT EMERGENCY MEETING

NOTICE IS HEREBY GIVEN, the Hunt County Commissioners Court will conduct an Emergency Meeting in accordance with Section 551.045 the Texas Open Meetings Act to address an emergency which has caused an urgent public necessity. The Emergency Meeting will occur at 2:00p.m. on April 9, 2020, at 2700 Johnson Street, Greenville, Texas, in the Auxiliary Courtroom by telephone or video conference in order to advance the public health goal of social distancing to slow the spread of the Coronavirus (COVID-19). Due to the COVID-19 crisis, the Governor's orders regarding social distancing, and special rules issued by the state regarding open meetings, there will be no public access to the location described above.
