The no new revenue rate is the total tax rate needed to raise the same amount of property tax revenue for Hunt County from the same properties in both the 2019-2020 tax year and the 2020-2021 tax year.

The voter approval rate is the highest tax rate that Hunt County may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the voter approval rate.

This budget will raise more revenue from property taxes than last year's budget by an amount of \$1,074,394 which is a 3.17% increase from last year's budget. The property tax revenue to be raised from new property added to the tax

## roll this year is \$1,074,394.
