

COMMISSIONERS' COURT MINUTES JANUARY 13, 1975

The Hunt County Commissioners' Court met in Regular Session, Monday January 13, 1975 at 10:00 a.m. in the Commissioners' Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Commissioner Henry L. Grimes.

Minutes for December 31, 1974 and January 2, 1975 were read and approved.

Judge Terrell read to the Court a letter from the Veterans Affairs Commission in Austin, Texas commending Veterans Service Officer Charles Beene on services provided for area veterans.

6 On a motion by James A. Speight, seconded by Johnnie H. Lyon, the Court confirmed the appointment of Lee Bostick as County Auditor by District Judge Hollis Garmon. All Voting AYE.

The Court passed on consideration of approval of the appointment and salary increase of Court Reporter Linda Willyard in order to have further discussion.

7 On a motion of Johnnie H. Lyon, seconded by Henry L. Grimes, the Court approved the Public Weigher bond of C. P. Holmes, with all members voting AYE.

8 On a motion of Johnnie H. Lyon, seconded by Henry L. Grimes, the Court voted to place I. H. McGee, Jr. on the payroll of Precinct #1 as a full time employee drawing a salary of \$423.50 per month. Mr. McGee is presently on the payroll as a part-time employee. All members voting AYE.

9 Acting on a request from the North Central Texas Council of Governments, the Court designated Judge Ed Terrell as official voting representative for 1974-1975. Motion was made by Johnnie H. Lyon, and seconded by Roy L. Holder with all voting AYE.

10 On a motion by James A. Speight, seconded by Roy L. Holder, the Court approved the appointments of Mrs. Teresa Vizenor as County Extension Agent and Miss Carolyn Flournoy as Assistant County Extension Agent, with all members voting AYE.

11 On a motion by Roy L. Holder, seconded by Henry L. Grimes, the Court granted a two (2) year contract to Mays and Company, Delinquent Tax Attorneys with all voting AYE.

The Court discussed a county audit with Mr. Peter B. Shannon of Earnest & Earnest Accounting Firm. Mr. Shannon informing the Court work could begin in April with the final audit report to be expected approximately the 1st of December. The audit to cover the year beginning September 1974 and ending September 1975. The Court took no action at this time.

12 Mr. Ray Culbertson presented to the Court a plat of Whisker's Retreat Phase 2. On a motion by Roy L. Holder, seconded by Johnnie H. Lyon, the Court voted unanimously to accept for filing, the Plat Whisker's Retreat Phase 2, with the stipulation sewers and roads be not accepted at this time.

13 On a motion by James A. Speight, seconded by Johnnie H. Lyon, the Court voted unanimously to delay division of Voting Box 33 in order to study the matter further. All members of the Court voting AYE.

Mr. Mike Holder of Precinct 1 addressed the Court concerning roadwork in the area of Money Cemetery. Mr. Holder and other area residents want the road rocked. Commissioner Lyon informed Mr. Holder sufficient funds had not been paid for the road work and the weather had not permitted any work on that road. Commissioner Lyon stating the road would be rocked when the necessary funds had been applied and the weather permitted.

14 County Court at Law Judge Phil Fugitt came before the Court to discuss furnishing the Juvenile Detention Center on the 5th floor of the Courthouse. On a motion by Roy L. Holder, seconded by James A. Speight, the Court voted to allow Judge Phil Fugitt to order a television, one table, six chairs, a refrigerator, six mattresses, one dozen boys uniforms and one dozen girls uniforms. All members of the Court voting AYE.

The Court also discussed with Judge Fugitt and Juvenile Probation Officer Dixon Latham, a bill from Boles Home for the Care of Jim Hoffman, in the amount of \$470.00. Jim Hoffman being placed in Boles Home by the Juvenile Court. No action was taken on the bill at this time.

15 On a motion by Henry L. Grimes, seconded by Roy L. Holder, the Court voted to authorize Judge Phil Fugitt to attend the National Juvenile Judges Conference in California, with all voting AYE. Expenses of

the trip to be paid out of Judge Fugitt's expense allowance.

Dixon Latham, Juvenile Probation Officer, told the Court of an arrangement with the Neighborhood Youth Corp to employ a secretary in the Probation Office at no cost to the County.

Mr. Winston Pritchard of Pritchard & Abbott came before the Court to offer his services.

At 11:35 a.m. Judge Ed Terrell recessed the Court to allow further examination of Monthly Accounts.

Court reconvened at 12:00 noon with all members present and Judge Ed Terrell presiding.

16 On a motion by Roy L. Holder, seconded by Johnnie H. Lyon, the Court voted unanimously to approve the monthly accounts for December 1974. Balance of accounts is as follows:
