COMMISSIONERS' COURT MINUTES FEBRUARY 24, 1975

The Hunt County Commissioners' Court met in Regular Session, Monday February 24, 1975 at 10:00 am in the Commissioners' Courtroom, Hunt County Courthouse, Greenville, Texas, with all members present and Judge Ed Terrell, presiding.

Invocation was given by Commissioner James A. Speight.

Minutes for February 10, 1975 were read and approved.

45 Joe Davenport, Mayor of Wolfe City, presented to the Court a proposal to provide emergency ambulance service to Wolfe City. In the proposal, the County would furnish funds for one new ambulance and equipment and would pay a set amount to Wolfe City each year to help defray the cost of upkeep of the vehicle. Wolfe City would provide two qualified persons to support the unit. On the recommendation of Judge Terrell, seconded by James A. Speight, the Court unanimously voted to take no action at this time in order to further study the proposal.

46 On a motion by Roy L. Holder, seconded by Henry L. Grimes, the Court approved the calling of a Special Election on Tuesday, April 22, 1975 for the purpose of adopting or rejecting two proposed State Constitutional Amendments with the voting boxes designated as follows and polling hours from 8:00 a.m. to 7:00 p.m.

The Court also agreed to allow the election judges to select the number of workers each felt he would need. All present voting AYE.

47 On a motion by James A. Speight, seconded by Roy L. Holder, the Court granted right of way requests in Commissioner Precin cts 3 and 4 to Southwestern Bell Telephone Co, with the stipulation cables be placed on back

slopes of roads and the County will not be responsible for damages done to roads. All present voting AYE.

- 48 On a motion by Roy L. Holder, seconded by JAMEes A. Speight, the Court granted the request of Tax-assessor Collector, Harold Armstrong for an extension phone in the Tax Office with all members present voting AYE.
- 49 On a motion by Roy L. Holder, seconded by Johnnie H. Lyon, the Court approved the following holidays for the year subject to change:

Motion carried with all present voting AYE.

- 50 On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court approved two requests for assistance. One by Richardine Taylor for Mrs. Willie Hunt of Greenville to provide transportation to John Seeley Hospital in Galveston and room and board for two days. Also the Court approved a request for assistance by Ms. Billie Anderson for her parents, Mr. & Mrs. A. O. Bethea to M. D. Anderson Cancer Clinic in Houston for room and board for three days and transportation. Requests were granted with all present voting AYE.
- 5! On a motion by Roy L. Holder, seconded by James A. Speight, the Court approved payment of a bill from the City of Greenville for ambulance service to the County in the amount of \$2,233.63 for a period beginning July 1, 1975 and ending December 31, 1974. Motion carried with all present voting AYE.
- 52 On a motion by Johnnie H. Lyon, seconded by James A. Speight, the Court approved a payroll change in the Juvenile Probation Office. John D. Scott was removed from the payroll and Frank Jones was added to the payroll effective February 15, 1975 with all present voting AYE.
- 53 Sheriff Wayne Green informed the Court that beginning in March, deputies would receive a \$15.00 per month expense allowance for uniforms. Sheriff Green also requested the Court to authorize \$100.00 for materials to move a door and repair a wall in the Sheriff's Office. Both items presented by the Sheriff were approved on a motion by Roy L. Holder, seconded by Johnnie H. Lyon with all present voting AYE.

Sheriff Green presented to the Court a check in the amount of \$1,263.01 in settlement of an insurance claim.

54 Motion was made by Henry L. Grimes, and seconded by James A. Speight, to advertise for bids for a new car for the Sheriff's Department with trade—in of a 1973 Plymouth, now out of use. No action was taken on this motion.

Following further discussion, Commissioner Grimes withdrew his motion.

- 55 Motion was made by Roy L. Holder, and seconded by James A. Speight, to allow the purchase of a sixth car for the Sheriff's Department. All members present voting AYE.
- 56 On a motion by James A. Speight, seconded by Henry L. Grimes, the Court voted unanimously to advertise for bids to sell a 1973 Plymouth and to advertise for bids to purchase a new car for the Sheriff's Department, white in color, with trade-in of a 1973 Plymouth with the check in settlement of an insurance claim in the amount of \$1,263.01 to be applied to the purchase of the new car.

There being no further business, Judge Ed Terrell adjourned the Court.
