HUNT COUNTY COMMISSIONERS' COURT MINUTES, MARCH 24, 1975

The Hunt County Commissioners' Court met in Regular Session Monday March 24, 1975 at 10:00 a.m.in the Commissioners' Courtroom, second floor, Hunt County Courthouse, Greenville, Texas. All members were present with Judge Ed Terrell presiding.

Invocation was given by Judge Ed Terrell.

Minutes for March 10, 1975 were read and approved.

- 65 On a motion by Johnnie H. Iyon, seconded by James A. Speight, the Court reappointed C. P. Holmes as Public Weigher, Precinct 1, with term of office to expire at the next general election. The Court also approved Mr. Holmes'Public Weigher's Bond and authorized him to appoint a Deputy Weigher from the Farmers Coo p Elevator, Greenville, Texas. This motion was approved with all members of the Court voting AYE,
- On a motion by Judge Ed Terrell, seconded by Johnnie H. Lyon, the Court unanimously approved the removal of Mike Abbott and the addition of Roger McLennon to the payroll of the Juvenile Detention Center.
- 67 On a motion by Roy L. Holder, seconded by James A. Speight, the Court unanimously approved three payroll changes in the County Clerk's Office. These changes being: the addition of Mrs. Betty Duncan effective March 1, 1975 at a salary of \$436.00 per month; the removal of Mrs. Janet Samford effective April 1, 1975; and the addition of Mrs. Jean Henslee effective March 15, 1975 at a salary of \$473.50 per month.
- 68 On a motion by Roy L. Holder, seconded by James A. Speight, the Court unanimously approved the addition of C. L. Hunt to the payroll of Commissioner Precinct 3 effective March 16, 1975 at a salary of \$436.00 per month.
- 69 On a motion by James A. Speight, seconded by Roy L. Holder, the Court unanimously approved a request by Charlie J. Walden, Justice of the Peace, Precinct 2, to increase his salary to \$486.00 per month, being equal to that of the Constable Precinct 2, effective April 1, 1975.
- 70 On a motion by Johnnie H. Iyon, seconded by James A. Speight, the Court approved a right of way request for Southwestern Bell Telephone Company im Commissioner Precinct 1 with the stipulation cables be placed on back slopes of roads and the County Will not be responsible for damages done to roads. All members of the Court voting AYE.
- 7/ On a motion by Henry L. Grimes, seconded by Johnnie H, Lyon, the Court unanimously approved the replacement of a P.A. system for a Texas Highway Patrol unit.
- 72. On a motion by James A. Speight, seconded by Henry L. Grimes, the Court unanimoulsy approved tax cancellation certificates numbers 20-29 and 59-62.
- 73 On a motion by James A. Speight, seconded by Johnnie H. Lyon, the Court voted to place the following sign on both ends of the County parking lot on Johnson street across from the Courthouse:

-Warning Notice-

This property has been leased to individuals employed by Hunt County. Any unauthorized Motor vehicles in designated parking s-paces will be towed away and impounded at the violator's expense.

The motion to post this sign carried with Commissioners Johnnie H. Iyon, Roy L. Holder and James A. Speight voting AYE. Commissioner Henry L. Grimes voted: NO.

74 On a motion by Judge Ed Terrall, seconded by Johnnie H. Lyon, the Court voted to defer from opening bids for a car for the Sheriff's Department for two weeks to allow car dealers more time in which to submit bids. Motion carried with all present voting AYE.

There being no further business Judge Ed Terrell adjourned the Court. Minutes read and approved this the Mark day of April 1975.
