COMMISSIONERS' COURT MINUTES, APRIL 14, 1975

The Hunt County Commissioners! Court met in Regular Session, Monday: April 14, 1975 at 10:00 A.M. in the Commissioners! Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Commissioner Henry L. Grimes.

18 On a motion by Roy L. Holder, seconded by Johnnie H. Lyon, the Court unanimously approved Minutes for March 24, 1975 Regular Session.

The Court also unanimously approved the Minutes for March 24, 1975 Special Session.

- 79 On a motion by Roy L. Holder, seconded by James A. Speight, the Court unanimously agreed to accept the bid of Grady Cheverolet of Greenville for a 1975 Cheverolet 4—door sedan equip ped with a police package in the amount of \$4359.00 less trade—in of \$450.00 for a 1973 Plymouth bringing the net cost to \$3909.00.
- 80 On a motion by Johnnie H. Iyon, seconded by Henry L. Grimes, the Court voted to allow the purchase of a 1968 Dodge 1 ton truck with winch for Commissioner Precinct 1, at an approximate cost of \$1100.00, with all members of the Court voting AYE.
- 8/ On a motion by James A. Speight, seconded by Henry L. Grimes, the Court unanimously approved right of way requests by Southwestern Bell Tele phone Company to lay cable in Commissioners Precincts 2 and 4 with the stipulation cables be placed on back slopes of roads and the County will not be responsible for damages done to roads.
- 92 On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court voted unanimously to accept with regret the resignation of County Attorney Sterling Newcomb, effective April 30, 1975.
- 83 On a motion by Henry L. Grimes, seconded by John/nie H. Lyon, the Court voted unanimously to appoint Assistant County Attorney, Richard W. Carter, to fill the remaining term of Sterling Newcomb, County Attorney. Mr. Carter's term of office to expire at the next general election.
- 84 On a motion by Roy L . Holder, seconded by Henry L. Grimes, the County Clerk's Office was granted a request for an extension telephone with all members of the Court voting AYE.
- On a motion by Roy L. Holder, seconded by James A. Speight, the Court voted to add Mr. Jerry Morrow to the payroll of the Juvenile Probation Office at a salary of \$600.00 per month. Mr. Morrow is presently on the staff of the Juvenile Probation Office, working as a Professional Service Employee under the CETA Manpower Program. Mr. Morrow is being added to the County payroll in order to enable him to partici pate in the County's retirement and health insurance programs. Mr. Morrow will continue to draw his salary under the Manpower Program and will in turn reimburse the County in the amount of his salary. Motion was approved with all members of the Court voting AYE.
- On a motion by James A. Speight, seconded by Roy L. Holder, the Court agreed to reimburse the County Tax Office \$20.00 for a counterfeit bill with all present voting AYE.
- 87 On a motion by Henry L. Grimes, seconded by James A. Speight, the Court voted to set May 27, 28, and 29 as hearing dates for the Hunt County Board of Equilization, with all present voting AYE.
- 88 On a motion by Roy L. Holder, seconded by Johnnie H. Lyon, the Court voted to accept for filing the Second Revised Plat of Club Terrace Addition owned by Mr. J. D. McCaghren with the stipulation that any problems concerning the boundaries will be the responsibility of Mr. McCaghren. All members of the Court voting AYE.
- 87 On a motion by Henry L. Grimes, seconded by Roy L. Holder, the Court voted to pass on consideration of return ing platted property to acreage until the owner, Mr. Raiford Stainback, can be present. All members present voting AYE.
- 90 On a motion by James A. Speight, seconded by Henry L Grimes, the Court unanimously approved Tax Cancellation certificates number 30 through 32.
- 9/ On a motion by Henry L. Grimes, seconded by James A. Speight, the Court voted to authorize Sheriff Wayne Green to purchase 1 letter size filing cabinet for the Sheriff's Office at the best possible price, with all members of the Court voting AYE.
- **92** On a motion by Henry L. Grimes, seconded by James A. Speight, the Court unanimously approved a request by Sheriff Green to allow the Sheriff and one other officer to attend an Instructors School at East Texas State University from April 21 through April 25 at a cost of \$10.00 each.
- 93 On a motion by Judge Terrell, and seconded by Roy L. Holder, the Court voted to accept as official, the Hunt County School Board Trustee Election returns. All members present voting AYE.
- 94 On a motion by James A. Speight, seconded by Henry L. Grimes, the Court unanimously approved accounts for the month of March, 1975. Balance of accounts is as follows:
