

COMMISSIONER'S COURT MINUTES, MAY 12, 1975

The Hunt County Commissioner's Court met in Regular Session, Monday May 12, 1975 at 10:00 A.M. in the Commissioner's Courtroom, Hunt County Courthouse, Greenville, Texas, with all members present and Judge Ed Terrell presiding.

Invocation was given by the Reverend Curtis Perry.

Minutes of the April 28, 1975 Regular Session were read and approved.

109 On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court approved right of way requests by Continental Telephone Company in Commissioner Precinct 2 with the stipulation cables be placed on back slopes of roads and the County will not be responsible for damages done to roads. Motion carried with all members of the court voting AYE.

110 On a motion by Henry L. Grimes, seconded by Roy L. Holder, the Court unanimously approved the addition of Mr. Donald Parks to the County Attorney's Office as administrative assistant effective May 15, 1975 at a salary of \$700.00, until such time as Mr. Parks can be licensed and then he will be moved to the position of Assistant County Attorney at a salary of \$850.00 per month.

111 On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court unanimously approved the bond of County Attorney, Richard W. Carter.

112 On a motion by James A. Speight, seconded by Roy L. Holder, the Court granted the request of the Probation Office to allow Mr. Jerry Morrow to attend a workshop at the University of Texas at Arlington for four nights at a cost of \$40.00. The request was allowed with all present voting AYE.

113 On a motion by Johnnie H. Lyon, seconded by Henry L. Grimes, the Court unanimously approved the removal of Cinda Mays and Mrs. Dera Patterson from the payroll of the County Clerk's Office effective May 1, 1975.

114 On a motion by Johnnie H. Lyon, seconded by Henry L. Grimes, the Court unanimously approved the addition of Mrs. Teresa Dodson to the payroll of the County Clerk's Office at a salary of \$401.00 per month effective May 12, 1975.

115 On a motion by Roy L. Holder, seconded by James A. Speight, the Court unanimously agreed to allow Sheriff Wayne Green and Juvenile Probation Officer Dixon Latham to take prices on a washing machine to be used by the jail and the Juvenile Detention Center and to present the best price on a washing machine to the County Judge and the County Auditor for authorization to purchase.

116 On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court voted to amend the Hunt County Road Specifications to read " Surface roads in additions to be eighteen to twenty foot width, with # 1 rock four to six inches in thickness and oil surfacing to be three to four inches in thickness. " Motion carried with all present voting AYE.

117 On a motion by Roy L. Holder, seconded by Johnnie H. Lyon, the Court named Commissioner Henry L. Grimes as voting representative to the Regional Transportation Policy Advisory Committee of the North Texas Council of Governments, with all members of the Court voting AYE.

118 On a motion by Johnnie H. Lyon, seconded by Henry L. Grimes, the Court voted to endorse the Hunt County School Board as sub-contractor on local Manpower programs with all members of the Court voting AYE.

119 Acting on a request by the North Texas Council of Governments, Mr. Bill Switzer, County Commissioner in Denton County was nominated for the Council of Governments Executive Board on a motion by James A. Speight, seconded by Roy L. Holder, with all members of the Court voting AYE.

120 On a motion by James A. Speight, seconded by Roy L. Holder, the Court approved three payroll changes in the Sheriff's Office. Those changes being the removal of Bill Williams from the payroll effective May 2, 1975, the moving of David Sikes to the position of an outside deputy at a salary of \$555.00 per month, and the addition of Carl Dunlap as an inside deputy at a salary of \$436.00 per month. Motion carried with all members present voting AYE.

121 On a motion by James A. Speight, seconded by Roy L. Holder, the Court unanimously approved accounts for the month of April, 1975. Balance of accounts is as follows:
