

The Hunt County Commissioner's Court met in Regular Session, Monday July 14, 1975 at 10:00 A.M. in the Commissioner's Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Greenville Chief of Police, Leon Powers.

Minutes of the June 20, 1975 Equalization Board meeting; the June 20, 1975 Public Hearing and the June 23, 1975 Regular Session were read and approved.

152 On a motion by Johnnie H. Lyon, seconded by Roy L. Holder, the Court unanimously approved five right-of-way requests by Southwestern Bell Telephone Company in Commissioner Precinct 1, 2, and 3 with the stipulation cables be placed on back slopes of roads, cables must be placed at a depth of 36 inches, and the County will not be responsible for damages done to roads.

153 On a motion by James A. Speight, seconded by Henry L. Grimes, the Court unanimously approved entering a revised agreement with the U.S. Department of the Interior concerning predatory animal control. The revised agreement would mean an increase in the Hunt County Portion in the amount of \$25.00.

154 On a motion by Roy L. Holder, seconded by James A. Speight, the Court approved the removal of Mr. Clayton Hart from the payroll of Commissioner Precinct 3 effective the last of June and the addition of Ricky Connors at a salary of \$436.00 per month effective July 14, 1975. Motion carried with all members of the Court voting AYE.

155 Motion was made by Johnnie H. Lyon and seconded by James A. Speight, to authorize the payment of \$65.00 for fees to allow Sheriff Wayne Green to attend a Jail Management Seminar in Amarillo on August 4-8 with the cost of fees to be reimbursed to Hunt County by the Criminal Justice Council in Austin. Motion carried with all members of the Court voting AYE.

156 On a motion by James A. Speight, seconded by Johnnie H. Lyon, the Court unanimously approved the following payroll changes in the Hunt County Sheriff's Office: Jerry Leverett was promoted to chief deputy at a salary of \$710.00 per month; I. D. Smith was promoted to captain at a salary of \$650.00 per month; G. Lee Duncan was moved to a salary of \$555.00 per month; George Reep, Jr. was moved to a salary of \$555.00 per month; Roy Randolph was removed from the payroll effective June 30, 1975; Anthony Hill was added to the payroll as dispatcher-jailer at a salary of \$436.00 per month, effective July 1, 1975; Michael Abbott was added to the payroll as dispatcher-jailer at \$436.00 per month effective July 1, 1975; and George Reep and Carl Dunlap are to receive \$15.00 per month clothing allowance.

157 Acting on a request by Sheriff Wayne Green, a motion was made by Henry L. Grimes and seconded by James A. Speight to allow the County Auditor to see if it would be possible to purchase two typewriters for the Sheriff's Office at the cost of the most recent bids submitted to the Court. Motion carried with all members of the Court voting AYE.

158 On a motion by Johnnie H. Lyon, seconded by Henry L. Grimes, the Court unanimously voted to allow Mr. and Mrs. William J. Korbolic of Commissioner Precinct 1 to lay a 2 inch water line along county right of way with the stipulation the Korbolic's will assume responsibility for any damages caused by the laying or maintaining of the line and the line must meet all county specifications.

159 On a motion by Roy L. Holder, seconded by Johnnie H. Lyon, the Court voted to accept for filing the plat Sandra Acres owned by W. H. Dishough with the stipulation the easement road would have to meet County specifications to be approved and the platted area must meet county specifications for additions. Motion carried with all members of the Court voting AYE.

160 Motion was made by James A. Speight, and seconded by Henry L. Grimes to approve the drawing of a resolution concerning the approval of distribution of County depository funds. Motion carried with all members of the Court voting AYE.

161 Billy Haddock, Probation Officer, presented to the Court a financial report concerning the Probation Department with a request the County pick up funding of the Probation Department. The grant under which two full time employees and one part time employee have been funded has expired. Motion was made by James A. Speight and seconded by Roy L. Holder to pick up funding of the Probation Department until October 1, 1975. Motion carried with Commissioners Lyon, Holder and Speight voting AYE and Commissioner Grimes voting NO.

162 District Attorney Jerry Davis came before the Court to request approval of the Criminal Justice Council grant which funds the Assistant District Attorney and a secretary for the District Attorney's Office. Mr. Davis also requested the County take on funding of the District Attorney's Investigator at a salary of \$10,500 per year. The grant under which the investigator has been funded expires this year. Mr. Davis told the Court refusing to fund the investigator could possibly eliminate the funding by the Criminal Justice Council of the Assistant District Attorney and the secretary. Motion was made by Judge Ed Terrell and seconded by Roy L. Holder to approve the grant for the Assistant District Attorney and secretary and give notice of intent to pick up funding of the position of investigator at the present salary of \$10,500 per year as of October 1, 1975 and that the investigator be provided a gas mileage allowance. Motion carried with all members of the Court voting AYE.

Mr. Sandy Sandefur, representative for Transport Life Insurance spoke before the Court concerning a supplemental cancer policy his company would like to provide for county employees. The Court told Mr. Sandefur the matter would be taken under advisement.

163 On a motion by James A. Speight, seconded by Henry L. Grimes, the Court approved accounts for the month of June, 1975 with all members of the Court voting AYE. Balance of accounts is as follows:
