COMMISSIONER'S COURT MINUTES, AUGUST 11, 1975

The Hunt County Commissioner's Court met in Regular Session, Monday, August 11, 1975 at 10:00 A.M. in the Commissioner's Courtroom, Hunt County Courthouse, Greenville, Texas with Commissioners Johnnie H. Lyon, Henry L. Grimes, and Roy L. Holder present and Commissioner James A. Speight absent, and Judge Ed Terrell presiding.

Invocation was given by County Auditor Lee Bostick.

Minutes of the July 28, 1975 Regular Session were read and approved.

Motion was made and withdrawn by Commissioner Henry L. Grimes to let Judge Ed Terrell discuss the possible rewording of the contract presented to the Court for consideration by Pritchard & Abbott, Tax Appraisers.

- 166 On a motion by Johnnie H. Lyon, seconded by Roy L. Holder, the Court unanimously agreed not to approve the contract presented by Pritchard & Abbott, Tax Appraisers, as presented to the Court.
- On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court approved two revised plats of parts of Crazy Horse Addition, already on file in the County Clerks Office, with all members present voting AYE.
- On a motion by Roy L. Holder, seconded by Henry L. Grimes, the Court voted to remove Mr. Leslie Cox from the payroll of Commissioner Precinct 3 effective July 25, 1975 and to remove Mr. Buddy Stewart and Neal Dunlap from the payroll of Commissioner Precinct 3 effective August 15, 1975. Motion carried with all members of the Court voting AYE.
- 169 Motion was made by Roy L. Holder and seconded by Henry L. Grimes, to request the return of \$50,887.95 credited to Hunt County by the Board of County & District Road Indebtedness. These monies to be designated for the repair and maintanence of existing lateral roads in Hunt County. Motion carried with all members of the Court voting AYE.

Judge Terrell presented to the Court a letter from Mr. Allen Zidell, President of Texas Resort Properties concerning a road leading into Waco Bay Estates. Commissioner Roy Holder told the Court the road is an all-weather road and is being maintained by the County. The Court unanimously agreed to allow Commissioner Holder to maintain the Road as he sees fit.

Judge Terrell presented to the Court a petition signed by approximately 400 persons asking the Court to consider the Dallas Pump Station Road as a future Farm to Market Road. The Road is presently owned by the City of Dallas, and is not a county road, however the Court agreed to consider the request.

Mrs. Warren H. Constant spoke before the members of the Court concerning the effectiveness of the Hunt County Sheriff's Department. Mrs. Constant feels the office is not doing all it can. No action was taken by the Court.

170 On a motion by Johnnie H. Lyon, seconded by Roy L. Holder, the Court unanimously approved two right of way requests by Southwestern Bell Telephone Company in Commissioner Precincts 1 and 3 with the stipulation cables be placed on back slopes of roads and the County will not be responsible for damages done to roads.

- 111 On a motion by Roy L. Holder, seconded by Johnnie H. Lyon, the Court unanimously approved a request by Raymond Hill to amend the plat "Rabbit Cove" by ordering the Closing of a designated undeveloped road in the Rabbit Cove Addition. The area included in the road would be taken in by adjoining lots.
- Motion was made by Judge Terrell and seconded by Henry L. Grimes to nominate the following persons as members for a seven person Child Welfare Board: Precinct 1- Ross Hall, Wolfe City, Texas, Principal & Coach; Precinct 2- W. A. Turner, Caddo Mills, Texas, School Principal; Precinct 3- Mrs. Fayrene Lowry, Greenville, Texas, Housewife; Precinct 4- Dr. Henry Harris, Commerce, Texas, Medical Doctor; Members At Large- Elmer Cummings, Jr., Greenville, Texas, Postal Worker- Rev. Tom Peel, Commerce, Texas, Minister - and Arlee Butler, Quinlan, Texas, Banker. Motion carried with all members of the Court voting AYE.
- 173 On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court voted to approve two right of way requests by Continental Telephone Company with the stipulation cables be placed on back slopes of roads and the County will not be res possible for damages done to roads. Motion carried with all members of the Court voting AYE.
- 00 a motion by Johnnie H. Lyon, seconded by Henry L. Grimes, the Court unanimously approved accounts for the month of July, 1975. Balance of accounts is as follows:
