COMMISSIONER'S COURT MINUTES, OCTOBER 27, 1975

The Hunt County Commissioner's Court met in Regular Session, Monday October 27, 1975 at 10:00 A.M. in the Commissioner's Courtroom, HuntCounty Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Commissioner Johnnie H. Lyon.

Minutes of the October 13, 1975 Regular Session were read and approved.

- 219 On a motion by Henry L. Grimes, seconded by James A. Speight, the Court voted to accept the resignation of Miss Jean Spradling as Chief Office Deputy in the District Attorney's Office effective October 31, 1975.

 Motion carried with all members of the Court voting AVE.
- 220 Motion was made by Roy L. Holder and seconded by James A. Speight to promote Miss Debra Coppinger to Chief Office Deputy in the District Attorney's Office at a salary of \$600.00 per month effective October 31, 1975. Motion carried with all members of the Court voting AYE.
- 221 Motion was made by Johnnie H. Lyon and seconded by Henry L. Grimes to allow the City of Celeste to lay a water line across County Roads east of Celeste with the stipulation the lines must meet all county requirements for buried lines and the County will not be responsible for damages. Motion carried with all members of the Court voting AVE.

Consideration of three plats owned by Mr. Tom Sawyers was passed as Mr. Sawyers was not present. Consideration of approval of these plats to be placed on the agenda for the next Regular Session of the Court.

Judge Ed Terrell presented to the Court the following Resolution concerning Vacation Time for County Employees:

WHEREAS:

HUNT COUNTY HAS MANY LOYAL AND FAITHFUL EMPLOYEES WHO HAVE SERVED THE CITIZENS OF THIS COUNTY FOR MANY YEARS: AND

WHEREAS:

NO MEANS HAS BEEN PROVIDED FOR ADDITIONAL COMPENSATION FOR LONGEVITY OF SERVICE: THEREFORE BE IT RESOLVED:

THAT EACH EMPLOYEE WITH 1 TO 5 YEARS SERVICE BE ALLOWED 10 DAYS VACATION TIME, THAT EACH EMPLOYEE WITH 5 TO 10 YEARS CONTINUOUS SERVICE BE ALLOWED 12 DAYS VACATION TIME, THAT EACH EMPLOYEE WITH 10 TO 15 YEARS CONTINUOUS SERVICE BE ALLOWED 13 DAYS VACATION TIME, AND THAT EMPLOYEES WITH 15 OR MORE YEARS CONTINUOUS SERVICE BE ALLOWED 15 DAYS VACATION TIME.

Motion was made by Commissioner Roy L. Holder to approve the above resolution as presented to the Court. Motion died for lack of second.

221 Motion was made by James A. Speight and seconded by RoyL. Holder to allow 15 days vacation time for employees with 15 or more consecutive years service, effective January 1, 1976. Motion carried with all members of the Court voting AYE.

223 Judge Ed Terrell recommended the following resolution be approved by the Court.
