

COMMISSIONER'S COURT MINUTES, DECEMBER 8, 1975

The Hunt County Commissioner's Court met in regular session, Monday, December 8, 1975 at 10:00 A.M. in the Commissioner's Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by County Attorney Richard Carter.

Minutes of the November 24, 1975 regular session and the December 1, 1975 emergency session were read and approved.

259 In opening business, Judge Terrell called for a vote on Motion # 255 of the November 24th regular session, said motion concerning the concept of county-wide reappraisal of property in Hunt County. Judge Ed Terrell and Commissioner James A. Speight voted AYE, Commissioner Johnnie H. Lyon voted NO and Commissioners Henry L. Grimes and Roy L. Holder abstained from voting. Judge Terrell declared the motion defeated as it failed to receive support from a majority of the Court.

260 On a motion by James A. Speight, seconded by Johnnie H. Lyon, the Court approved Public Weighers bonds for Glenda Tucker and James Watts, each in the amount of \$2500, with all members of the Court voting AYE.

No action was taken on the regionalization of Mental Health and Mental Retardation services, in order to allow further study.

261 Motion was made by Johnnie H. Lyon and seconded by James A. Speight, to allow Continental Telephone Company a right of way request in Commissioner Precinct 1 with the stipulation cables be placed on back slopes of roads and the County will not be responsible for damages. Motion carried with all members of the Court voting AYE.

262 On a motion by Henry L. Grimes, seconded by James A. Speight, the Court unanimously approved payment for the right of way for FM 3218 on the following parcels of land:

Also included in approval for payment is an easement from the Veterans Land Board of Texas.

263 On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court approved the purchase of five public information films by the Sheriff's office, to be made available to the public for viewing, at a cost of \$300.00. Motion carried with all members of the Court voting AYE.

264 On a motion by Johnnie H. Lyon, seconded by Roy L. Holder, the Court unanimously approved the removal of Kenneth Burks from the payroll of the Sheriff's Department effective December 5, 1975 and the addition of Allen Bridges effective December 6, 1975 at \$436 per month.

Members of the Court acknowledged and discussed the Hunt County Grand Jury request for improved jail facilities. No action was taken at this time.

265 On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court unanimously approved accounts for the month of November, 1975. Balance of accounts is as follows:
