COMMISSIONERS COURT MINUTES, FEBRUARY 9, 1976

The Hunt County Commissioners Court met in Regular Session, Monday, February 9, 1976 at 10:00 A.M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with Commissioners Johnnie H. Lyon, Henry L. Grimes, Roy L. Holder and James A. Speight present and Judge Ed Terrell presiding.

Invocation was given by Commissioner Johnnie H. Lyon.

A bid on a 1974 Dodge was recieved from J W Motors of Route 3, Greenville in the amount of \$288.50. The Court was in agreement to pass on taking action on this bid as it was believed there has, as of this date, been no advertising for bids on this car.

Minutes of the January 26th regular and emergency sessions were read and approved.

Commissioner Roy L. Holder called to the attention of the Court that he had placed Jerry Crane back on the payroll of Commissioner Precinct 3, on Mr. Crane's return to work after a leave of absense.

- 287 On a motion by Henry L. Grimes, seconded by Roy L. Holder, the Court approved a request by Marjorie Moore of the Child Welfare Office to allow three people to attend the 1976 Child Abuse Conference in Dallas at a cost of \$75.00 for the registration fees. Motion carried with all members of the Court voting AYE.
- 288 On a motion by Johnnie H. Lyon, seconded by James A. Speight the Court approved right of way rejuests by Continental Telephone Company in Commissioner Precincts 1 and 4 with the stipulation cables be placed on back slopes of roads and the County will not be responsible for damages. Motion carried with all members of the Court voting AYE.

A Continental Telephone Co. right of way in Commissioner Precinct 2 was passed until a request by Commissioner Henry Grimes that no pedestals be errected on open farm lands could be implemented into the right of way agreement.

A request to change the lock on the District Attorney's Back door was passed.

- 289 On a motion by Henry L. Grimes, seconded by Johnnie H. Iyon, the Court voted to allow the District Clerk to purchase a check protector from a Sulphur Springs dealer at a cost of \$290.00 with all members of the Court voting AYE.
- 270 Motion was made by James A. Speight and seconded by Henry L. Grimes to authorize Crocket Tile Co. to repair the ceiling of the County Courtroom on the 4th floor of the Courthouse at an estimated cost of \$350.00. Motion carried with all members of the Court voting AYE.
- 291 On a motion by Roy L. Holder, seconded by James A. Speight, the Court unanimously voted to pass on consideration of a nominee to the governing board of the Health Services Association of North Central Texas.

 The Court agreed to Study the request further before taking any action on the matter.
- 292 On a motion by HenryL. Grimes, seconded by Johnnie H. Lyon, the Court voted to accept a resolution authorizing a Pavement Marking Demonstration Project between Hunt County and the Texas Department of Highways and Public Transportation for the purpose of Applying control safety striping on county roads. Motion carried with all members of the Court voting AYE.

A RESOLUTION

Authorizing a Pavement Marking Demonstration Project Between Hunt County and the Texas Department of Highways and Public Transportation.

WHEREAS, the Texas Department of Highways and Public Transportation has come before the Hunt county Commissioners Court asking that the county Join with it in a program to promote better traffic safety on the County's roads, and;

WHEREAS, the Federal Government has made funds available through the Federal Highway Administration to finance cooperative efforts between local and state governments for the purpose of developing and implementing projects which will aid in the better control of vehicular traffic on county roads, and;

WHEREAS, the Governor's Office of Traffic Safety, in conjunction with the Texas Department of Highways and Public Transportation has ascertained that there is a need to develop a demonstration program in the state

in the area of pavement marking for traffic safety and control, and;

WHEREAS, the Commissioners Court of Hunt County is in agreement with the Governor's Office of Traffic Safety that development and implementation of a Pavement Marking Demonstration Program in the County would be beneficial and in improvement of the safety of County roads for its citizens through extensive striping, and;

WHEREAS, the Texas Department of Highways and Public Transportation agrees to finance a Pavement Marking Program for Hunt County from Federal Highway Administration funds received by the Governor's Office of Traffic

Safety.

THEREFORE, Be it resolved that the Commissioners Court of Hunt County agrees to join with the Texas Department of Highways and Public Transportation in developing and implementing a Pavement Marking Demonstration Program for the purpose of applying control safety stripping on County Roads.

243 A motion was made by Roy L. Holder, and seconded by James A. Speight to call a County School Board Election for Saturday, April 3, 1976 for the purpose of electing two county school board members. Motion carried with all members of the Court voting AYE.

294 On a motion by James A. Speight, seconded by Johnnie H. Lyon, the Court unanimously approved accounts for the month of January, 1976. Balance of accounts is as follows:
