COMMISSIONERS COURT MINUTES, MAY 24, 1976

The Hunt County Commissioners Court met in Regular Session, Monday May 24, 1976 at 10:00 A. M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Juvenile Officer Jerry Morrow.

Minutes of the May 10, 1976 Regular Session were read and approved.

- 346 On a motion by Johnnie H. Iyon, seconded by Henry L. Grimes, the Court agreed to the following payroll changes in the County Tax Office: Cindy Clark is added to the payroll effective May 3, 1976 at \$436.00 per month, Mrs. Carrie Shipp is removed from the payroll on her retirement on April 30, 1976, and Dorothy McQueen is moved to \$473.50 per month effective May 1, 1976. Motion carried with all members of the Court voting AYE.
- 347 On a motion by Roy L. Holder, seconded by Henry L. Grimes, the Court voted to add Ronnie Posey to the payroll of Commissioner Precinct 3 effective May 17 at \$2.30 per hour as summer part-time help and add Noble Ketchum to the payroll of Commissioner Precinct 3 effective May 24, 1976 at \$2.30 per hour as summer part-time help. Motion Carried with all members of the Court voting AYE.
- 347 On a motion by James A. Speight, seconded by Roy L. Holder, the Court voted to revise a prior Order # 104 of April 28, 1975 authorizing Texas Power & Light to relocate electrical facilities along proposed FM 3218 right os way with Hunt County to reimburse Texas Power & Light in the amount of \$14,297.00. The amount of reimbursement of the cost of the relocation is revised to the amount of \$16,537.00. Motion to approve this revision carried with all members of the Court voting AYE.
- 349 On a motion by Johnnie H. Lyon, seconded by Henry L. Grimes, the Court voted unanimously to enter into the minutes of the Court, as a matter of record, the completion of a twenty hour course in the responsibilities of the office of Justice of the Peace by Judge R. L. Mullins of J.P. Precinct 3. This course was completed at the Texas Justice of the Peace Training Center, Southwest Texas State University, San Marcos, Texas.
- 350 On a motion by James A. Speight, seconded by RoY L. Holder, the Commissioners' Court of Hunt County, Texas hereby Resolve to approve and support the application of the North Central Texas REgional Youth System, Phase I, for a grant for the Deinstitutionbalization of Status Offender, regarding juvenile deliquency related problems. Said grant application to the made to the Criminal Justice Division of the Governor's Office in the amount of \$83,000.00, and Hunt County will accept responsibility for the administering of grant monies. Motion carried with Commissioners Henry L. Grimes, Roy L. Holder and James A. Speight voting AYE and Commissioner Johnnie H. Lyon voting NO.
- 35/ On a motion by Roy L. Holder, seconded by Henry L. Grimes, the Court voted to correct the Whites Prairie voting Box 32 from the designation of being in Justice of the Peace and Constable Precinct 4 to the designation of being in Justice of the Peace and Constable Precinct 5 and Commissioner Precinct 3. Motion carried with all members of the Court voting AYE.
- 352 On a motion by James A. Speight, seconded by Roy L. Hölder, the Court approved registration fees in the amount of \$20.00 each for the District Attorney, County Attorney, Assistant County Attorney and the District Attorney's Investigator to attend a Texas District and County Attorneys Conference in Fort Worth on June 9, 10, & 11th. Motion carried with all members of the Court voting AYE.

There being no further business before the Court, Judge Ed Terrell recessed until 1:00 P.M. at which time the Court will reconvene as a Board of Equalization.

Speight, the Court approved the consolidation of voting boxes 14 and 17, both of Campbell, for the June 19, 1976 Special Congressional Election to be held in Congressional District 1 for the purpose of electing a Congressman to fill the unexpired term of the Honorable Wright Patman, deceased. Motion carried with all members of the Court voting AYE.

There being no further business to be considered, Judge Ed Terrell adjourned the Court from Emergency Session.
