COMMISSIONERS COURT MINUTES JUNE 14, 1976


The Hunt County Commissioners Court reconvened as a Board of Equalization, Monday, June 14, 1976 at 10:00 A.M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with Commissioners Johnnie H. Lyon, Henry L. Grimes, Roy L. Holder and James A. Speight present and Judge Ed Terrell presiding.

Following a discussion of proposed tax collections for 1976-1977, Judge Ed Terrell recommended the consideration of decreasing the County Tax Rate from 95¢ per \$100 valuation to 80¢ per \$100 valuation, being a base rate of 65¢ per \$100 valuation ad valorem tax, plus 15¢ per \$100 valuation special road and bridge tax.

There being no further business to come before the Board, Judge Ed Terrell adjourned the Hunt County Board of Equalization for 1976.
