## COMMISSIONERS COURT MINUTES, JUNE 28, 21976

The Hunt County Commissioners Court met in Regular Session, Monday, June 28, 1976 at 10:00 A.M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with Commissioners Johnnie H. Lyon, Henry L. Grimes and James A. Speight present and Judge Ed Terrell presiding. Commissioner Roy L. Holder was absent.

Invocation was given by Judge Ed Terrell.

Minutes of the May 24, 1976 Regular Session, May 24-28, 1976 Equalization Board, June 14, 1976 Equalization Board, June 14 Regular Session, June 15, 1976 Emergency Session and June 22, 1976 Special Session were read and approved.

- 368 On a motion by James A. Speight, seconded by Henry L. Grimes, the Court approved payroll changes in the County Attorney's office. Gwinn Adams was removed from the payroll effective July 1, 1976, Ginger Coffman was promoted to top secretarial position at \$462.50 per month and Marilyn Corbett was added as a secretary at \$436.00 per month. Motion to approve these changes carried with all members of the Court voting AYE.
- 369 On a motion by James A. Speight, seconded by Henry L. Grimes, the Court agreed to accept for filing only, the plat "Wildwood Addition" in Commerce presented by Leroy Matkins and owned by Wildwood Home Builders, Inc. This acceptance is subject to the plat being recorded and does not constitute approval or acceptance of roads as shown within the addition. Motion carried with all members of the Court voting AYE.
- 570 On a motion by Johnnie H. Lyon, seconded by Henry L. Grimes, the Court approved the addition of Ricky Henslee to the Payroll of Commissioner Precinct 1 for the period from June 7, 1976 to June 30, 1976 at \$2.30 per hour. Motion carried with all members of the Court voting AYE.

County Clerk, Mrs. Bloom Johnson, requested the Court to consider replacing the Xerox Photostat machine which is no longer in use in the County Clerk's office with a Xerox 4000 copy machine. The Court agreed to take the request under study and contact the Xerox representative for cost estimates.

Jim Ainsworth and Kenneth Foust, Certified Public Accountants, presented their final audit report to the Court for the fiscal year ending September 30, 1975. The Court took no action on recommendations proposed in the report suggesting the report be studied and discussed further with Mr. Foust and Mr. Ainsworth at a later date.

Appointments to the Hunt County Committee on Aging were passed as members of the Court were not ready to name replacements.

Approval of a Resolution to the City of Commerce correcting information on certain parcels of land purchased from the City for FM 3218 was passed as a written resolution was not ready for the Courts consideration.

The Court recognized the election of Commissioner Henry L. Grimes as Second Vice President to the North and East Texas County Judges and Commissioners Association.

There being no further business, Judge Ed Terrell adjourned the meeting.
