COMMISSIONERS COURT MINUTES AUGUST 9, 1976

The Hunt County Commissioners Court met in Regular Session, Monday August 9, 1976 at 10:00 A.M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Mr. Martin Dooley.

Minutes of the July 26, 1976 Regular Session were read and approved.

Mr. George Betts appeared before the Court to thank the Court for providing the new office space for the Veterans Service Officer and for the services provided by the secretary in that office.

On a motion by James A. Speight, seconded by Roy L. Holder, the Court approved the following Resolution:

WHEREAS, The Legislature of the State of Texas has enacted certain statutory provision, to wit:

Article 4477-5, Vernon's Texas Civil Statutes, said statutory provisions commonly known as the Texas Clean

Air Act, and

WHEREAS, The intent of the Legislature in enacting said statutory provisions was to provide a means of preventing the presence of air contaminants in such concentration and of such duration as may tend to be injurious to or adversely affect human health or welfare, animal life, vegatation, or property, and

WHEREAS, The Commissioners Court of the County of Hunt, State of Texas desires that said statutory provisions be enforced whenever a violation or threat of violation of said provisions has occurred or is occurring in the unincorporated areas of Hunt County, Texas,

WHEREFORE, BE IT RESOLVED: That the Hunt County Commissioners Court hereby authorizes the County Attorney of Hunt County and his successors in office to institute a suit for injunctive relief or civil penalties, or both, whenever a violation or threat of violation of the hereinabove named statutory provisions has occurred or is occurring in the unincorporated areas of Hunt County, provided for in Section 4.03 of the said statutory provisions.

Motion to approve this resolution carried with Commissioners Henry L. Grimes, Roy L. Holder, and James A. Speight voting AYE and Commissioner Johnnie h. Lyon voting NO.

Mr. Paul Harney of Nob Hill Landowners Association spoke to the Court concerning roads in Nob Hill Addition east of Quinlan. The Court told the group the roads in the addition are private roads and may not be maintained by the County. If the roads are brought to County specifications and maintained for one year, the Court will consider the acceptance of the roads as county roads.

- On a motion by Johnnie H. Lyon, seconded by Henry L. Grimes, the Court approved the following payroll changes: in Commissioner Precinct 1, H. E. Gregory was removed from the payroll effective July 31, 1976 and Rickey Henslee was removed from the payroll effective August13, 1976; in Commissioner Precinct 2 Walter Howell was added to the payroll effective August 1, 1976 at \$2.30 per hour; and in Commissioner Precinct 3, Neal Dunlap was removed from the payroll effective August 4, 1976 and Robert Jones was added effective August 2, 1976 at \$2.30 per hour. Motion to approve these changes carried with all members of the Court voting AYE.
- 392 On a motion by Roy L. Holder, seconded by Henry L. Grimes, the Court voted to accept the resignation of Wayne Green as Hunt County Sheriff effective midnight August 15, 1976 and to authorize payment of two weeks unused vacation time. Motion carried with all members of the Court voting AYE.
- 393 On a motion by Roy L. Holder, seconded by Henry L. Grimes, the Court approved a Field Agreement between Hunt County and the U. S. Bureau of Sport Fisheries and Wildlife in which Hunt County agrees to pay to the Texas Animal Damage Control Association through the Texas Cooperative Trapping Fund \$425.00 per month for the protection of livestock and crops. This agreement becomes effective September 1, 1976 and continues until termination. Motion to approve carried with all members of the Court voting AYE.

394 A motion was made by Henry L. Grimes and seconded by Roy L. Holder to request the return of \$50,887.95 in Lateral Road Funds credited to Hunt County by the Board of County & District Road Indebtedness. This money to be designated for the repair and maintenance of existing county roads. Motion carried with all members of the Court voting AYE.

395 On a motion by Henry L. Grimes, seconded by Johnnie H. Lyon, the Court approved a request by the Mrs. Hunt County Committee to be allowed to place a 16 X 20 inch picture of the newly selected Mrs. Hunt County in the Courthouse each year with the cost to be carried by the Hunt County Fair Board. Motion to approve this request carried with all members of the Court voting AYE.

396 On a motion by Johnnie H. Lyon, seconded by Henry L. Grimes, the Court unanimously approved accounts for the month of July, 1976. Balance of accounts is as follows:
