Invocation was given by Commissioner Roy L. Holder.

Minutes of the October 11, 1976 meeting were read and approved.

- 452 On a motion by Commissioner Henry L. Grimes, second by James A. Speight, the court unanimously approved Sheriff Mark Blankenships' recommendation to accept a contract agreement with Jim Brashear for the servicing of County Radios, at \$71.00 per month.
- 453 On a motion by Commissioner Roy L. Holder, second by Johnnie H. Lyon, the court unanimously approved personnel changes for the tax office adding new employee Emma Sue Martin effective October 1, 1976, resignation of Comer Bernard effective October 31,1976, to be replaced by Mary Lou Stephens at a salary of \$622.50 per month and effective November 1, 1976 the promotion of Cindy Clark to a salary of \$523.50.
- 454 On a motion by Judge Ed Terrell, second by James A. Speight, the court unanimously approved an extra telephone for the Extension Office.
- #.550n a motion by James A. Speight, second by Roy L. Holder, the court unanimously approved the Right-Of-Way request for Southwestern Bell Telephone Company.
- The purchase of Fire Extinguishers was passed, until the yearly service charge could be checked on the bid submitted by North East Texas Alarm & Security Service.
- 4560n a motion by James A. Speight, second by Commissioner Roy L. Holder, the court unanimously approved the City-County Health Unit to apply for a Prenatal Clinic Grant, with no matching funds by the County.
- No action was taken on the Personnel Study presented by Jeff Harkinson and his assistant from North Central Texas Council of Government.
- 457 Commissioner Johnnie H. Lyon made a motion to rescind order # 437, giving the dog to Greenville Police
 Department, Greenville Independent School District or CODE. Motion was second by Commissioner James A. Speight
 and carried with Commissioners James A. Speight, Johnnie H. Lyon and Judge Ed Terrell voting AYE and Commissioners
 Henry L. Grimes and Roy L. Holder voting NO.
 - No action was taken on the road matter in Precinct 4, presented by Mrs. V.H. Bryant.
- 45% On a motion by Commissioner James A. Speight, second by Roy L. Holder, the court unanimously agreeded

to table until the next regular meeting, the continuation of the Public Hearing on the proposed Sewer Regulations.

- 459 On a motion by Commissioner Henry L. Grimes, second by Commissioner James A. Speight, the court unanimously approved the request for a water line by Jack Howard, in Precinct 2.
- 460 On a nomination by Commissioner Henry L. Grimes, second by Johnnie H. Lyon, Commissioner James A. Speight, was unanimously elected as MARC Representative to NCTCOG.
- 46! On a motion by Commissioner James A. Speight, second by Commissioner Roy L. Holder, the court unanimously approved a request by Sheriff Mark Blankenship to apply for a 5 year Grant for a County Juvenile Investigator, which if approved may be cancelled on a 30 day written notice.
- #62 On a motion by Commissioner Henry L. Grimes, second by Johnnie H. Lyon, the court unanimously approved the Tax Corrections on Certificates #51 through 54, then #1 through 9 and the Erroneous Tax Corrections #1 for Harold Armstrong, Tax Assessor Collector.
