

COMMISSIONERS COURT MINUTES, NOVEMBER 8, 1976

The Hunt County Commissioners Court met in Regular session, Monday, November 8, 1976 at 10:00 A.M., in the Commissioners Court Room, Hunt County Courthouse, Greenville, Texas, with all members present and Judge Ed Terrell presiding.

Invocation was given by Commissioner Henry L. Grimes.

Minutes of the October 25, 1976 meeting and the reconvened session of October 27, 1976 were approved as read.

— Consideration of approval to purchase Fire Extinguishers was tabled until the next regular session.

464 On a recommendation by Judge Ed Terrell, second by Commissioner James L. Speight, the court voted to adopt the proposed Sewer Regulations effective January 1, 1977, with the amendments to Section IV, Paragraph E made by John Butler. Commissioners Henry L. Grimes, James A. Speight, Roy Holder and Judge Ed Terrell voting AYE and Commissioner Johnnie H. Lyon voting NO. Mr. Ed Aymes and Sid Auten from Grayson County and Irvin Turner from the Texas Department of Health Resources were present for the discussion.

465 On a motion by Commissioner Henry L. Grimes, second by James A. Speight, the court voted unanimously to accept the bid from Faulkner Motor Company for 2-1977 police package autos with trade in a total of \$8,880.00 and the low bid on the 1976, with out trade for \$4,375.00 and to keep the 1974 Chevrolet for another year.

466 On a motion by Commissioner James A. Speight, second by Roy L. Holder, the court unanimously approved the Petition for the Local Option Election for the City of Neylandville to be held December 4, 1976, with the polls to be open from 7:00 A.M. to 7:00 P.M. Election Judges will be appointed the next regular meeting.

467 On a motion by Judge Ed Terrell, second by Commissioner Henry L. Grimes, the court unanimously approved the request by Don Parks to attend the Child Abuse Conference, November 18, 1976 in Dallas.

468 On a motion by Commissioner Henry L. Grimes, second by Johnnie H. Lyon, the court unanimously approved the request by the Juvenile Office for a new file cabinet.

469 On a motion by Commissioner Roy L. Holder, second by James A. Speight, the court unanimously approved the request of Commissioner Roy L. Holder to advertise for bids on a Wench Truck, Dump Truck and a Pickup in either a new 1976 or 1977 model, any color with trade in, for Precinct 3.

470 On a motion by Commissioner Roy L. Holder, second by James A. Speight, the court unanimously approved the re-inspection of the roads north and west in Lancer Estates. This does not include the east road.

471 On a motion by Commissioner Henry L. Grimes, second by Johnnie H. Lyon, the court unanimously approved the personnel changes by Sheriff Mark Blankenship as follows; removing from the payroll effective October 31, 1976 - Elaine Haynes, Luther Dixon, Carl Dunlap, Captian and Ed Sneed, Deputy; increasing Austin Stewart from \$486.00 to \$605.00 per month, adding Anthony Hill and Ronnie Garcia as Jailer-Dispatchers at \$486.00 per month, adding Ida Sing as Civil Clerk at \$486.00 per month, adding Bobby Young as Captian at \$700.00 per month and adding from the Traffic Safety Grant Program at \$605.00 per month- Mike Johnston and John Thomason and Jim Peek at \$655.00 per month.

472 On a motion by Commissioner Henry L. Grimes, second by Johnnie H. Lyon, the court unanimously approved the monthly accounts for October. Balance of the accounts are as follows:

475 On a motion by Commissioner Henry L. Grimes, second by Johnnie H. Lyon, the court unanimously approved the request by Sheriff Mark Blankenship for the auditor to contact the bonding company regarding the missing \$825.00 bond money from the jail Sunday afternoon and if the loss cannot be replaced by the bonding company, for the auditor to cover the loss with county funds.
