NOVEMBER 22, 1976

The Hunt County Commissioners met in regular session, Monday, November 22, 1976, at 10:00 A.M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Judge Ed Terrell.

Minutes of the November 8, 1976 Regular Session and the November 12, 1976 Special Session, were approved as read.

478 On a motion by Commissioner Roy L. Holder, second by Henry L. Grimes, the Court unanimously approved the bid of North East Texas Alarm and Security Service for Fire Extinguishers for the Courthouse in the amount of \$347.10 and \$52.00 for service.

- Consideration for approval of a Plat for Vincent Murphy-Wrangler's Rest was passes until the next regular meeting.

479 On a motion by Commissioner James A. Speight, second by Roy L. Holder, the Court unanimously approved the request by the County Auditors Office for the purchase of a new calculator.

481 On a Motion by Commissioner Henry L. Grimes, second by Roy L. Holder, the Court unanimously approved the application for Membership in Hunt County Farm Bureau for Hunt County.

484 On a motion by Henry L. Grimes, second by Johnnie H. Lyon, the Court unanimously approved the request by Marjorie Moore for Christmas needs for Child Welfare, to be taken out of the Child Welfare Budget and if they should run short before the year is out to help later in the year.

485 On a motion by James A. Speight, second by Roy L. Holder, the Court unanimously approved the request for the balance of funds allotted the Hunt County Committee on Aging, in the amount of \$2200.00

486 On a motion by Commissioner James A. Speight, second by Johnnie H. Lyon, the Court unanimously approved the following personnel changes for the Sheriff's Office: increase David Brooks from Investigator to Captain at \$700.00 per month, increase Dewey Swindell from Jailer-dispatcher to Certified Deputy at \$655.00 per month, increase Bobby Young from Captain to Chief Deputy at \$760.00 per month, add Billy Wade as Jail Cook at \$446.80 per month effective November 16, 1976 and drop W. T. Wallen from the payroll, effective November 15, 1976.
