## COMMISSIONERS COURT MEETING

JANUARY 14, 1980

The Hunt County Commissioners Court met in Regular Session, Monday, January 14, 1980 at 10:00 A.M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas, with all members present and Judge Ed Terrell presiding.

Invocation was given by Sheriff Bobby G. Young.

Minutes of the December 21, 1979 Regular Session were approved as read.

Bids open by the court:

//45 For sale of used 1952 Chevrolet Flat Bed Truck Precinct 4-

Roy Etter, Hugo, Oklahoma of \$500., Ernest Stewart, Commerce for \$400., E. A. Edward, Klondike for \$610. On the motion by Commissioner Mike Crowell, second by Johnnie H. Lyon, the court voted unanimously to accept the bid of E. A. Edwards for \$610.00 as the highest bid.

## 1146 Trucks for Precinct 2 from:

Lee Bender - 60 series \$9,497., 70 series \$10,998.; Williams Motor Co.- 60 series \$10,362., 70 series \$12,215.42 Grady Chevrolet - 60 series \$9,994., 70 series \$11,663.; Mahaney International - 60 series \$10,433., 70 series \$12,148.; On the motion by Commissioner Henry L. Grimes, second by Mike Crowell, the court voted unanimously to accept the lowest bid from Lee Bender if they meet with specifications.

Bids on the cars are tabled until this afternoon.

- Sally Barton appeared before the court as representive for the State National Bank of Caddo
  Mills regarding the taxes on the bank. An agreement was reached between the Tax Assessor and the bank without
  court action.
- // 47 Request of the Adult Probation Officer Charles Clemons for itelephone system to determine which office was on the line and the relocation of one instrument was unanimously approved by the court on the motion by Commissioner Mike Crowell, second by Judge Ed. Terrell.
- Judge Ed Terrell presented a Certificate of Certification to Norman Ulmer, Veteran Service Officer, from the Texas Veterans Service Association.
- //48 On the motion by Commissioner Mike Crowell, second by Roy L. Holder, the court approved the temporary appointment of Wayne Stringfellow to assistant Veterans Service Officer, with Commissioners Mike Crowell and Roy L. Holder voting AYE and Commissioners Henry L. Grimes and Johnnie H. Lyon voting NO. Judge Ed Terrell voting AYE to break the tie.
- One bid was received regarding the Insect control of the courthouse. Moss Pest Control for \$1,940 per year. This was passed for specifications and other bids.
- //49 Personnel changes County Attorneys Office replaced Vickie Summers with Diane Mullins at the same salary effective December 26, 1979. Juvenile Office, Bill Bryant to add Lynn Smith at same salary of Lynn Hopewell effective January 2, 1980. Approved unanimously by the court on motion by Commissioner Johnnie H. Lyon, second by Henry L. Grimes.

- ## Bids on the riot equipment for the Sheriffs Office was unanimously approved by the court or the motion by Commissioner Henry L. Grimes, second by Johnnie H. Lyon, from Betts & Majors, Inc for \$2,040.
- Right of Way request from Gulf States Telephone Company located in Precinct 4 was unanimously approved by the court on the motion by Commissioner Mike Crowell, second by Roy L. Holder.
- On the motion by Commissioner Roy L. Holder, second by Mike Crowell, the court unanimously approved the annual Tax Report for the Tax Office.
- // 53 On the motion by Commissioner Roy L. Holder, second by Johnnie H. Lyon, the court unanimously approved the cancellations and corrections for the Tax Roll.
- Three names were drew from the previous year of Grand Jury List to serve on the Grievance Committee: Estella Johnson, Napoleon Wright and Damon Farr.

- Part time help for the Justice of the Peace Office of Frank Lane was tabled for study.
- No action was taken on consideration of lease on school land.
- The court ask Judge Ed Terrell to proceed in locating storage space for the court house.

1/54 On the motion by Commissioner Mike Crowell, second by Roy L. Holder, the court voted unanimously granting permission to send revised plans to the Jail Commission for review.

//55 On the motion by Commissioner Mike Crowell, second by Roy L. Holder, the court unanimously approved a \$25.00 per month salary increase, amending the budget to reflect pay raises, and toward the end of the year if there is trouble in the Road and Bridge Salary Fund, money can be moved from the General Fund to help.

Monthly accounts for December were unanimously approved by the court on the motion by Commissioner Henry L. Grima second by Johnnie H. Lyon.

Court recessed.

Court reconvened.

//57 On the motion by Commissioner Henry L. Grimes, second by Johnnie H. Lyon, the court unanimously agreed to withdraw the motion to accept the bid from Betts and Majors for Riot Equipment for the Sheriffs Office.

1/58 The motion by Commissioner Johnnie H. Lyon to accept the lowest bid with trade in from Whilden Ford for three Sheriffs cars, died for lack of second. The Motion by Commissioner Mike Crowell, second by Roy L. Holder, the court voted to accept the low bid from Whilden Ford, but not to trade in the 1979 car (trade in two) for \$18,468.20 and for the Judge to use this car (or other members of the court) for travel. This will take the place of the Judges \$175.00 per month travel expense. With Commissioners Mike Crowell and Roy L. Holder voting AYE and Commissioner Johnnie H. Lyon voting NO. Commissioner Henry L. Grimes abstained from voting.

//59 The 1st inspection of the road off 2101 for Ken Hale was unanimously approved by the court on the motion by Commissioner Roy L. Holder, second by Henry L. Grimes. This is located in Precinct 3.

# 0 On the motion by Commissioner Henry L. Grimes, second by Roy L. Holder, the court voted unanimously to turn down the 1st inspection of the road located in Precinct 2 off Groves Road.
