## COMMISSIONERS COURT MEETING FEBRUARY 8, 1982

The Hunt County Commissioners Court met in Regular Session Monday February 8, 1982 at 10:00 A. M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Commissioner Henry Lee Grimes.

- Bids were opened by Judge Ed Terrell on Copy Machines from the IBM Company, Shelton Office Supplies, and Copy Products. Bids are on file in the Auditor's Office. Shelton Office Supplies is to bring thier machine into the County Clerk's Office to try, before any bids are approved.

1575 There were also bids on Road and Bridge Supplies from the following - Barnhardt's Steel, West Texas Culvert, and Texas Steel Culvert. The Court unanimously approved to accept the low bid from Texas Steel Culvert Co. on the culverts. This was made on the Motion by Henry L. Grimes, second by Johnnie H. Lyon. Also on the Motion by Johnnie H. Lyon, second by Henry L. Grimes, the Court unanimously approved to accept the bid from Barnhardt Steel Co. for the Bridge material.

- There were five bids opened on gasoline from the following - Bragg's Texaco, Horn Bros. (01) Co., Barton Good Oil Co., Leonard Farm Store, and Roy Watson Texaco. There was no action taken on these bids at this time. Bids are on file in the Auditor's Office.

1577 On the Motion by Johnnie H. Lyon. second by Roy L. Holder, the Court unanimously approved to accept the bid from Trinity Equipment Co. on a Motor Grader for Pct. 1, for 22,500, or with trade in for 19,000.

1578 There was a payroll change to add W. J. Dub Watson as mechanic for Pct. 3. This was unanimously approved by the Court on the Motion by Roy L. Holder, Second by Henry L. Grimes.

 There was a request from Tom Curtis, and Wayland Walker to inspect a Road, which the Court agreed to go inspect after Court adjourned.

- There were no Right Of Way request.

- There was no action taken at this time on lease of scales on Market Square.
