

COMMISSIONERS COURT MEETING

APRIL 12, 1982

The Hunt County Commissioners Court met in Regular Session, Monday April 12, 1982 at 10:00 A. M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Commissioner Johnnie Lyon. Minutes of the March 22, meeting were approved.

1609 There was a payroll change to remove David Kolb as of the first of April in Precinct 3, and was unanimously approved on the motion by Commissioner Roy Holder, second by Henry Grimes.

1610 The Commissioners Court unanimously approved a Right Of Way request from General Telephone Company of the Southwest, and one from Continental Telephone Co. on the motion by Commissioner Johnnie Lyon, second by Roy Holder.

— Presentation of the North Central Texas MH/MR annual report was given by Tubby Adkisson.

1611 On the motion by Henry Grimes, second by Johnnie Lyon, the Court unanimously approved a Resolution for a Quit Claim for the State on an existing Channel Easement located on Interstate 30 West.

1612 The Court unanimously approved a Preliminary Plat of Bent Oak West Subdivision for filing on the motion by Johnnie Lyon, second by Henry Grimes.

1613 On the Motion by Henry Grimes, second by Johnnie Lyon the Court unanimously approved the Final Plat of Hidden Oaks Estates in Pct. 2, and that the roads shall be 50 ft. of the Right Of Way.

1614 Charles Turner discussed a Hospital Contract with the Hospital District, and the Court unanimously approved to enter into a contract for one year at 2 percent, on the motion by Roy Holder, second by Mike Crowell.

1615 The Accounts for the last of March and the first of April were unanimously approved on the motion by Commissioner Johnnie Lyon, second by Henry Grimes.

1616 On the motion by Henry Grimes, second by Roy Holder, the court unanimously approved for the Auditor to advertise for bid specks to be determined for Justice Building for Pct. 4.

1617 Chuck Clemons spoke on a request for a COG Grant for drug educational program, and the Court unanimously approved to submit Grant to expand. This was on the motion by Mike Crowell, second by Roy Holder.

1618 The Court unanimously approved for the Auditor to advertise for bids to replace the cooling system in the County Court At Law Courtroom, and to specify size later, This was made on the motion by Johnnie Lyon, second by Henry Grimes.

— Judge Terrell read a letter from Gerald Jones of the Justice Dept. approving the electronic Voting System.
