

COMMISSIONERS COURT MEETING

AUGUST 23, 1982

The Hunt County Commissioners Court met in Regular Session Monday August 23, 1982 at 10:00 A. M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with all members present and Judge Ed Terrell presiding.

Invocation was given by Mike Crowell.

Minutes of the August 9, 1982 Regular Session were approved as read.

**1689** An Inducement Resolution Agreement by Hunt County Industrial Development Corporation to issue Bonds for the UTE Petroleum Industries was unanimously approved by the court on the motion by Roy Holder and second by Mike Crowell.

— A Resolution by the Hunt County Industrial Development Corporation providing for the issuance of Bonds For the Coca-Cola Bottling Company of Greenville, Inc. was passed until a later date.

— There were no payroll changes.

**1690** A Right-of-Way request by Able Springs Water Supply located in precinct #2 was <sup>unanimously</sup> approved by the Court with the usual stipulations. This was on the motion by Henry L. Grimes and second by Johnnie Lyon.

There was also a Right-of-Way request from Continental Telephone Company that was unanimously approved by the Court with the usual stipulations. This was on the motion by Henry L. Grimes and second by Johnnie Lyon.

**1691** The Monthly Accounts for August were unanimously approved by the Court on the motion by Henry L. Grimes and second by Johnnie Lyon.

**1692** On the motion by Roy Holder and second by Mike Crowell the Court unanimously approved the request from Robert Thompson for Medical Assistance. The request approved was to fill all prescriptions but not to exceed a 30 day supply. Eckerd Drug will call Judge Terrell and give the total price for all the prescriptions.

— Merrick Money, on behalf of the Fair Board, thanked the Commissioners Court for helping with the Fair and also discussed Insurance on the Fair Grounds.

— A presentation about the National Flood Insurance Program was presented by Ron Hunka, no action was taken at this time.

— Inspection of a road in Hidden Oaks was passed until a later date.

**1693** The Court unanimously approved the V A Service Officer to attend a Training Seminar in San Antonio. This was on the motion by Henry L. Grimes and second by Johnnie Lyon.

— Linda Bradshaw from the Telephone Company discussed the Telephone needs for the Criminal Justice Center, No Action was taken at this time.


— There was a discussion by Mrs. Bloom Johnson concerning the Voting Boxes. No Action was taken at this time. Court recessed until 1:00 P. M.
