The Hunt County Commissioners Court met in Regular Session Monday November 8, 1982 at 10:00 A. M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with all members present with Judge Ed Terrell presiding.

Invocation was given by Commissioner Johnnie Lyon.

Minutes of the October 25, 1982 Regular Session were approved as read.

1937 Bids were opened by Judge Terrell on insect and rodent control. Bids were from Mason Pest control, Randy Meeks and Moss Pest Control. The Court unanimously approved the bid from Moss Pest Control, on the motion by Roy Holder, second by Mike Crowell.

173 Bids were also opened for four Cars for the Sheriff's Office. Bids were from Grady Cheverolet, and Cole-Chrysler-Dodge. The Court accepted the low bid from Cole-Chrysler-Dodge. Grady's bid was \$36,396.00, and Cole's was 34,218.80. The motion was made by Mike Crowell, and being second by Judge Terrell, with Crowell and Holder voting aye, and Lyon and Grimes opposed. Judge Terrell voted aye and motion carried.

1943 The Court unanimously approved the accounts on the motion by Johnnie Lyon, second by Roy Holder. 1944 The Replat change of Redhawk Bay Development was unanimously approved on the motion by Roy Holder, second by Henry Grimes.

1945 The Court unanimously approved Bill Green as Nominee for the Hunt County Committee on Aging. This was made on the motion by Henry Grimes, second by Johnnie Lyon.

null on the motion by Mike Crowell, second by Roy Holder, the Court unanimously approved that F. M. Road 1568 be designated as Maloy Road.

1139 The Court unanimously approved the payroll change in the County Clerk's office, to remove Lynn Chandler, and add Linda Brooks as of November 1. This was approved on the motion by Henry Grimes, second by Johnnie Lyon. Court recessed until 1:30

Court reconvenued at 1:30 with canvassing the Election Returns.

Court recessed at 4:00 P. M. until Tuesday at 9:00 A. M.

Courtareconvenued at 9:00.A. M. November 9, continueing Canvassing Election Returns.

The Court certified the Election Returns.

Court adjourned.
