

COMMISSIONERS COURT MEETING

NOVEMBER 22, 1982

The Hunt County Commissioners Court met in Regular Session Monday November 22, 1982 at 10:00 A. M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas with all members present with Judge Ed Terrell presiding.

Invocation was given by Commissioner Mike Crowell.

Minutes of the November 8, Regular Session and the November 15, and 18th., Special Called Meetings were approved as read.

1743 Court opened with opening of bids for Computer Services for the Auditor's office. There was one bid received and that was from User Systems Inc. Upon the motion from Mike Crowell and being second by Judge Terrell, the Court unanimously accepted the proposal from User Systems Inc.

1744 The Court unanimously approved the Final Plat of Hidden Oaks # 2, in Precinct 2, upon the motion by Henry Grimes, second by Mike Crowell.

— Gloria Slack gave a report on the Family Crisisline Program for Hunt County.

— There were no payroll changes.

1745 There was a Right of Way request from Gulf States United Telephone Co. in Precinct 4, that was unanimously approved on the motion by Mike Crowell, second by Johnnie Lyon.

1746 The Monthly Accounts were unanimously approved on the motion by Johnnie Lyon, second by Mike Crowell.

1747 Increased Benefits in Texas County District Retirement Services were adopted by the Court. On the motion by Roy Holder, second by Johnnie Lyon, the Court unanimously adopted Plan # 1.

1748 The Court passed an order to participate in Federal Aid Bridge Program. This was unanimously approved on the Motion by Henry Grimes, second by Johnnie Lyon.

1749 There was a motion by Henry Grimes, second by Johnnie Lyon to recend the action taken on the Final Plat of Hidden Oaks # 2, until proper production is produced. This was unanimously approved.

1750 On the motion by Henry Grimes, second by Johnnie Lyon, the Court unanimously approved authorization to advertise for bids for a ½ ton pickup, and a tractor truck for precinct 2.

— Judge Terrell brought before the Court recommendations for a investment schedule of CD's. No action was taken.


