

The Hunt County Commissioners Court met in Regular Session Monday, January 24, 1983 at 10:00 A. M. in the Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas, with all members present with Judge J. W. Bill Green presiding.

Invocation was given by Judge Green.

Minutes of the January 10, 1983 Regular Session were approved as read.

— Chuck Clemmons discussed the proposed contract between the Probation Department and the County before the Court, which the Contract will be signed by the 196th. District Judge, and the County Judge.

1787 On the motion by Johnnie Lyon, second by Mike Crowell, the Court unanimously approved the payroll change to remove Faith Teel, and add Lorie Shuler half time effective January 24, 83 in the Hunt County Extension Office. On this motion, the Court unanimously approved additional travel expenses for Mel Matthews for 4H agriculture, to allow up to \$250.00 as needed a year, and that he would turn in his bills.

1788 The Court unanimously approved to set back the date for delinquent taxes, and set the date March 1, 83. This is for ¹⁹⁸² taxes collected by the County only. This was unanimously approved on the motion by Henry Grimes, second by Roy Holder.

— The Fire Department meeting will be held in Caddo Mills.

1789 Don Morris submitted a plat for a subdivision called Wheatland Acres Phase 1, on I-30 in Precinct 2. The Court unanimously approved that filing be postponed on the motion by Johnnie Lyon, second by Roy Holder.

— Filing will also be postponed on a plat regarding a division of 500 acres.

1790 There were payroll changes in the Sheriff's office to remove Donna McLeod effective 1-15-83 and Wynell Greenlee effective 1-28-83. Due to vacation, Mrs. Greenlee will lack 12 Hours drawing a full check for this month. Added is Vida Dorice Burkas, Matron-Dispatcher, effective 1-21-83, salary \$925.00 per month, and Elizabeth Ann Robertson, Matron-Dispatcher, effective 1-24-83, salary \$950.00. There was a payroll change in maintance to remove Helen Eldridge, and add Bill Reynolds. These payroll changes were unanimously approved on the motion by Roy Holder, second by Henry Lee Grimes.

— There was no action regarding Police units.

1791 The Court unanimously approved to advertise for bids for the rest-rooms to be repaired and remodeled. This was unanimously approved on the motion by Henry Grimes, second by Johnnie Lyon.

1792 On the motion by Henry Lee Grimes, second by Roy Holder the Court unanimously approved that George W Nita Adkisson and Roslyn Davis be re-appointed to the North Central Texas Mental Health Committee.

1793 The Court unanimously approved on the motion by Henry Lee Grimes, second by Roy Holder to pay dues to the National Association Of Counties.

1794 On the motion by Johnnie Lyon, second by Roy Holder the Court unanimously approved the payroll change in Gloria Peters JP's office to remove Karen Colley, effective 1-18-83 and add Kendi Olmstead at \$915.00 effective 2-1-83.

1795 The Court Canvassed and unanimously approved the Election Returns of the Bingo Election on the motion by Henry Grimes, second by Johnnie Lyon, Bingo Election was defeated by 310 against and 72 for and consisted of Boxes 10,34,24, and absentee.

1796 There was a motion by Commissioner Johnnie Lyon, and second by Commissioner Henry Lee Grimes to recess until 10:00 A. M. Tuesday for the purpose of interviewing and possibly selecting a Veteran's Officer.
