

COMMISSIONERS COURT MEETING

MARCH 26, 1984

The Hunt County Commissioners Court met in Regular Session Monday March 26, 1984 at 10:00 A. M. in the Hunt County Commissioners Courtroom, Greenville, Texas with all members present with Judge J. W. Bill Green presiding.

Invocation was given by Commissioner Henry Lee Grimes.

Minutes of the March 12, 1984 Regular Meeting were approved as corrected on # 2160, to read that 3598.50 was total price for everything.

2172 On the motion by Commissioner Henry Grimes, second by Johnnie Lyon the Court unanimously approved the easement request ^{inst. 2} from Continental Telephone Company with a letter sent to Continental requesting that all telephone lines be put on back slopes.

2173 Carlene Dooley, JP request for full time help was unanimously approved with grade I salary and effective April 1, 1984. This was approved on the motion by Henry Grimes, second by R. J. Smith.

2174 On the motion by Henry Grimes, second by Mike Crowell, the Court unanimously approved to reject all bids on Repeater Communication Systems.

2175 The Court unanimously appointed W. P. Phillips MD, Physician for the new Criminal Justice Center, on the motion by Henry Grimes, second by R. J. Smith.

2176 The Preliminary Plat of Shady Lane Subdivision in Precinct 3 was unanimously approved with the stipulation that no Construction to be done until Final Plat is approved and filed, and 4inch water line be installed which residents will pay for. This was approved on the motion by R. J. Smith, second by Mike Crowell.

— The Preliminary Plat of Sunset Acres was taken off the Agenda.

— Protest to Sunset Acres was taken off Agenda.

2177 Bids received on new motor grader for Precinct 4 were from George P. Bane, Inc. bid of \$ 78,340.00 with & (no air) discount. Darr Equipment Company, had four bids- 89,519.00, 91,889.00 with air, 87,737.00, 90,126.00 with air, Trinity Equipment Company, 83,882.73, 87,172.73 with air., Plains Machinery Company, 70,235.00, 72,635.00 with air. 75,639.00, 78,039.00 with air. On the motion by Mike Crowell, second by Henry Grimes, the Court unanimously approved the bid from Plains Machinery Company # A550, 1-H466 with air for 78,039.00. Auditor has bids in file.

2178 On the motion by Henry Grimes, second by R. J. Smith the Court unanimously approved the mileage certification of each Precinct for Hunt County.

2179 On the motion by Commissioner Johnnie Lyon, second by R. J. Smith the Court unanimously approved to take no action today in connection with landfill for North Texas Services.

— Sewer Easement for the City of Quinlan will be passed until later date.

— There were no change orders on the Criminal Justice Center today.

2180 On the motion by Henry Grimes, second by Johnnie Lyon the Court unanimously approved the payroll changes in Precinct 3 to raise Russell Harold Frost from Operator to Bridge Foreman effective March 15, and in the Sheriff's office raise Kenneth Robinett to Deputy at 1247.00 effective March 16, and add Thomas Charles Jenkins as Jailer at 973.00 effective March 22, 1984, and James Rafford Stibbens Precinct Worker in Precinct 2, at 1071.00 effective March 19, 84

2181 The accounts payable for March was unanimously approved on the motion by Johnnie Lyon, second by Grimes.

2182 The Court unanimously approved the Final Plat and changes of High Hollow Subdivision in Precinct 3 on the motion by R. J. Smith, second by Henry Grimes.

Court recessed 5Minutes.

2183 There was a discussion on the road that was named Roberts Road, on the motion by Mike Crowell, second by Johnnie Lyon the Court unanimously approved to retain the name Roberts Road.
