HUNT COUNTY COMMISSIONERS COURT MEETING

September 10, 1984

The Hunt County Commissioners Court met in regular session at 10:00 am in the Commissioners Courtroom with all members present & Judge Bill Green presiding. Henry Grimes delivered the invocation.

OLD BUSINESS:

- On the motion by Johnnie Lyon, second by R.J. Smith, the Court voted unanimously to deny approval of the Fair Oaks Estate subdivision preliminary plat for David Lambert until Commissioner Lyon & Mr. Lambert could meet and go over certain details to the plat request.
 - 2325 On the motion by Lyon and second by Grimes, the Court unanimoulsy voted to deny the request of approval at this time the Hendricks Addition preliminary plat.
 - 2326 On the motion by Smith, second by Lyon, the Commissioners agreed to inspect the Shady Grove South subdivision during the noon break before approving the plat.
 - The Court passed over the Buena Vista Subdivision plat approval because Gerald Pickering was not in attendance.

NEW BUSINESS:

- 2327 Amotion was made by Lyon, second by Smith to approve the guidelines for the Hunt County Fair Board as drawn up by the County Attorney. Following dicussion with Bobby Harris, who heads the Fair Board, the Court agreed to meet with Harris & the Fair Board before approving any guidelines. Lyon & Smith withdrew the motion & second.
- 2328 The Court on the motion by Grimes & second by Crowell, unanimoulsy approved a resolution by State Rep. Smith Gilley proclaiming September as "Register to Vote Month" in Hunt County.
- 2329 On the motion by Smith, second by Grimes, the Court agreed that the County Attorney should review the Co-operative Agreement between the State & Hunt County for the H.C. Health Dept.
- 2330 On the motion by Grimes & second by Smith, the Court unanimoulsy approved the final plat of the Mockingbird Subdivision for Frank McClain. In attendance, representing McClain, was Jim Patterson.
- 233 On the motion by Smith, second by Grimes, the Court agreed to the figure of 42¢ per \$100 valuation as the rate of tax filed for the 1984-85 budget. This action paves the way for required budget hearings. Motion approved at 10:45 a.m.
- 2332 On the motion by Lyon & second by Grimes, the Court approved the easement request of Hopewell Water Supply. Said easement is near the old landfill site outside Peniel.
- 2333 On the motion by Lyon & second by Grimes, the Court approved the easement request of Continental Telephone Co. in Pct. 1.
 - The Court heard from a representative of Blue Cross/Blue Shield of Texas regarding group coverage insurance. The proposal is being taken under consideration. No action taken.
- The Court heard from Sheriff Bobby Youg regarding final details that need to be completed in order to open the Criminal Justice Center. No action was taken.
- The Court heard from Ken's Communication regarding certain equipment that needs to be repaired or replaced at the communications tower. No formal action taken.
- 2334 On the motion by Lyon & second by Grimes, the Court approved the Accounts Payable.
 - There were no personnel or payroll changes.
- 2335 On the motion by Lyon, second by Crowell, the Court gave permission to the Senior Ladies use of the Courtmouse basement on Saturday, Oct. 27th for a quilting exhibit.
 - The Court heard from Mary Thomas regarding ambulance service in Hunt County. No formal action was taken.

 The Court recessed until 2:30 p.m.

The Court reconvened at 2:30 with Commissioner Crowell absent due to illness.

- 2336 On the motion by Smith & second by Lyon, the Court agreed to allow Wayland Walker to make the necessary changes on the old Shady Grove South subdivision final plat which will become the Shady Grove south subdivision preliminary plat. Approval of which to be acted upon in the future.
- 2337 On the motion by Grimes & second by Lyon, the Court agreed to endorse a firefighters contract to be presented to the area fire departments for their approval. Unanimous aye vote.
- 2338 On the motion by Grimes & second by Lyon, the Court accepted the 1984-85 cooperative agreement for the Greenville-Hunt County Health Dept.
- 2339 On the motion by Lyon & second by Grimes, the Court approved the filing of the Salem Acres subdivision prelim.

 plat with the stipulation it states 'Preliminary Plat'. Unanimous vote.

Emergency meeting

September 14, 1984--9:00 a.m.

The Hunt County Commissioners Court met with the Hunt County Fair Board at the request of the Fair Board. All members were present and Judge Green presiding. The purpose of the meeting was to discuss the guidelines drawn up by the Commissioners Court.

2340 A motion was made by Henry Grimes to appoint 3 members from the Court and 3 members from the Fair Board to a committee to resolve differences between the Courts version of an agreement & that of the Fair Board's.

The motion died for lack of a second. After much discussion, the Court & Fair Board agreed to a tentative set of guidelines which will formally acted upon at the next Court meeting. Meeting Adjourned.

PUBLIC HEARING

September 19, 1984--10:00 a.m.

The Commissioners Court met with all members present and Judge Green presiding. Judge Green gave the invocation and then announced that the purpose of the meeting was for a public hearing on the proposed tax rate for the 1984-85 budget. The meeting was closed at 10:40 a.m.
