Replaces Judy Snyder who becomes Court Reporter at \$16,344 per year. Sheriff Dept.: Add Ray Mattix, effective 10-1-84 at \$1,023.00 per mo. Remove Thomas Jenkins effective 9-30-84. Motion by Grimes, second by Lyon. Unanimous.

The Court met with Steve Ramsey regarding liability insurance for the proposed Juvenile Detention Center. After much discussion, the Court recessed until 2:00 pm on Tuesday.

1376 The next day, on the motion by Crowell, second by Lyon, the Court approved the contract with Rockwall & Kaufman Counties with the stipulation that Hunt County can get a minimum of \$500,000 liability coverage at a maximum premium of \$5,000.
