REGULAR MEETING NOVEMBER 26, 1984

The Commissioners Court met in regular session this day at 10:00 am in the Commissioners Courtroom. All members were present & Judge Green presiding. Invocation was given by R.J. Smith. Minutes of the last meetings were approved as read with the noted exception on order number 2404.

OLD BUSINESS:

- **2430** On the motion by Johnnie Lyon, second by Smith the Court unanimously agreed not to pay the salary supplement to District Attorney F. Duncan Thomas, and further, in the event that Hunt County is forced to pay the D.A. the supplement, then all juvenile board members should be paid the \$100 per mo.
 - Request for easements in Pct. 1,2,63 by Continental Telephone Co. of TX. were referred to old business next court date.
 - The item to discuss misinformation regarding lot in Quinlan-Larry Bailey will be dropped from the Court's agenda.

NEW BUSINESS:

--- Request for final plat approval on Fair Oaks Subdivision in Pct. 1-David Dick, was passed over & will be considered at a later date.

- **2431** Regarding the request for preliminary plat approval on Meadowcreek Estates, Trail Dust Estates East & West-Pct. 3 (Russ Butcher) the following action took place: On the motion by Smith, second by Henry Grimes the Court unanimously accepted the three preliminary plats with the stipulation that the width of the roads are in the deed restrictions, that the plats are for filing purposes only, and that in the final plat the roads will be 60 ft. and utility easements will be in place.
- 2432 On the motion by Johnnie Lyon, second by Grimes, the Court authorized the Auditor to have the Sheriff's Dept. build the shelves for the ID Clerk in the Criminal Justice Center. The Court then discussed parking at the new Criminal Justice Center. After much discussion,
- 2433 on the motion by Smith & second by Lyon, the Court voted 3-1 to charge employees \$5.00 per month to park on the southern two thirds of the lot west of the CJC, and allow the northern part of that lot for visitor parking, running a cable east & west to divide the two sections. Fees collected will be used to upgrade the lots. For: Lyon, Grimes, Smith;Opposed: Crowell.
- 2434 For the record: The Court agreed to move the following offices to the Criminal Justice Center: Sheriff Dept.; Justice of Peage Pct. 1, Places 1 & 2; Game Wardens; Hwy. Patrol; Texas Ranger; the Constable Pct. 1--Motion by Grimes, second by Smith-Unanimous vote.
- 2435 On the motion by Grimes, second by Lyon, the Court authorized the auditor to inventory all equipment and machines (incl. Furniture) at the Criminal Justice Center. Unanimous vote. The Court heard from Sam Armstrong regarding fire services-No action taken.
- The Court discussed part-time maintenace help for the Criminal Justice Center. No action taken. 2436 The Court discussed office entrances and other items for the Justices of Peace offices in
 - the Criminal Justice Center. On the motion by Lyon, second by Grimes, the Court unanimously agreed to make no changes to the CJC at this time.
 - ---- Recommendations to the Board of Review members for the Hunt County Appraisal District will be under old business at the next Court meeting.
- **2437** On the motion by Crowell, second by Smith, the Court adopted a resolution regarding business firms and individuals who contract with Hunt County and owe delingufit taxes or other debts. Unanimous vote.
- Request for second road inspection for Grande Verde Phase I & II subdivision in
- Pct. # 2- Ode Veldman was passed on to old business at the next court meeting.
- **2438** On the motion by Smith, second by Lyon, the Court unanimoulsy agreed to file an injunction regarding T.W. Morrison subject to County Attorney approval.
- 2439 On the motion by Crowell, second by Smith, the Court voted to meet only once in regular session in December (2nd Monday) and to take Tuesday, Jan. 1st, 1985 as a holiday.
- No action was taken on the E-Systems letter regarding toxic waste.
- **2440** On the motion by Grimes, second by Crowell, the Court agreed to hand deliver the monthly checks to the Volunteer Fire Depts. at their regular monthly meetings.
- **2441** On the motion by Grimes, second by Crowell, the Court unanimoulsy approved the accounts payable.
