

REGULAR SESSION
July 8th, 1985

The Hunt Co. Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with Judge Bill Green, Johnnie Lyon, and Henry Grimes present. Prayer given by Henry Grimes. Minutes of the past meetings were approved as read.

OLD BUSINESS:

— AT&T proposal on telephone systems will be considered under OLD BUSINESS next meeting.

2637 On the motion by Grimes, second by Lyon, the Court unanimously agreed to postpone action on the High Hollows, Phase II Section B, final plat approval request in Pct. #3, Triple J. Realty Co. until the next regular meeting (OLD BUSINESS).

— Consideration of plat on Twin Haven Mobile Home Park, Pct. #2-Paulette Brannan will be taken up the next regular meeting (OLD BUSINESS).

NEW BUSINESS:

— Request approval of preliminary plat for Wagner Subdivision in Pct. #1-Glendon Womble will be under OLD BUSINESS at the next regular meeting.

2638 On the motion by Lyon, second by Grimes, the Court voted to approve the prelim. plat request on Wolfe Run Estates, Pct. #1-Alan Wolfe. Green, Grimes, Lyon voted Aye.

2639 On the motion by Grimes, second by Lyon, the Court approved the final road inspection on Wheatland Acres, Phase II and Grande Verde, Phase II in Precinct #2 with the following conditions: Wheatland Acres--Mr. Morris will sweep the gravel back up on the road&take care of the asphalt bleeding through on the road. Grande Verde--one of the culverts leading into one of the lots be covered with dirt.

Voting aye: Green, Grimes, Lyon.

2640 Regarding the resolution dealing with liability and worker's compensation on the Work Release Program: On the motion by Lyon, second by Grimes, the Court agreed to having a resolution ~~be~~ drawn up in that anyone using these workers will furnish liability & workers compensation releaving the County of responsibility which isn't covered by the County's workers comp. program. Resolution to be signed on 7-22-85.
Green, Grimes, Lyon voting AYE.

2641 On the motion by Lyon, second by Grimes the Accounts Payable were approved.
