FEBRUARY 24, 1986

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present and Judge Green presiding. Opening prayer was given by Henry Grimes. Minutes of the previous meeting were approved as read.

OLD BUSINESS:

2861 On the motion by John Mizell, second by Grimes, the Court approved the easement request for Tawakoni Water Corp. on Whiskers Rd. in Pct. #3.

NEW BUSINESS:

2862 Request for final plat approval on Pecan Creek Subdivision, Pct. 1-Glendon Womble: Granted on the motion by Johnnie Lyon, second by Grimes. Unanimous Vote.

— Request for approvals of replat on Harold Morris Farms, Pct. 3-Harold Morris:

OLD BUSINESS NEXT MEETING.

2863 Request for final plat approval on Harmon Addition, Pct. 2-Ronald Harmon: Granted on the motion by Grimes, second by Mike Crowell.

2864 On the motion by Grimes, second by Lyon, the Court granted the refund of \$ 909.93 in taxes paid in error by 'Countess Country'.

Action taken on bids opened:

2865 (1) On the motion by Mizell, second by Lyon, the Court awarded the bid for road oil to Bryan & Bryan @ \$30.34 per barrel.

2866 (2) One bid was received on asphalt but not considered because of delinq. taxes. On the motion by Grimes, second by Lyon, the Court agreed to using the existing vendor until new bids can be considered & awarded.

2868 (4) No bids were received on maintenance of air conditioner at the Criminal Justice Center. On the motion by Grimes, second by Lyon, the Court agreed to use the existing vendor until new bids can be considered and awarded.
