

REGULAR SESSION
May 12, 1986

The Hunt Co. Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present & Judge Green presiding. Opening Prayer was given by Johnnie Lyon. Minutes of the previous meetings were approved as read.

OLD BUSINESS:

2917 Request for preliminary plat approval on Greenwolfe Acres, Pct. 1-Bob Adams: Approved on the motion by Lyon, second by John Mizell.

2918 On the motion by Lyon, second by Mizell, the Court rescinded order #2877 regarding Oak Estates preliminary plat.

2919 On the motion by Lyon, second by Henry Grimes, the Court approved the amended preliminary plat on Oak Estates.

— The request for preliminary plat approval on Salem-Kinser Estates, Phase I, Pct 1- Jerry Wisdom: OLD BUSINESS NEXT MEETING.

NEW BUSINESS:

2920 On the motion by Grimes, second by Lyon, the Court adopted a resolution (per Section 33.07, TX. Property Code) providing for an additional 15% of current delinquent taxes due, effective 7/1/86. Unanimous Vote.

— Drop from agenda item #2-'Consider approval of disbursements of funds with regard to payment to Comptrollers Office-Joyce Barrow.'

— Drop from the agenda item #3-'Request for plat approval on High Hollows, Phase II, Section B, Pct 3.

— The Court heard from Roy Childs regarding the dissolution of North Central TX. MH/MR. The Court agreed to pass this item until next meeting. Court will consider then possible legal counsel for Hunt County regarding the assests of NCT MH/MR.

2921 On the motion by Grimes, second by Crowell, the Court accepted the low bid of TX. Steel Culvert Co. for galvanized corrugated metal pipe & metal sheets.

2922 On the motion by Mizell, second by Grimes, the Court accepted the proposal of AT&T for a new telephone system in the Court House at a price of \$23,275.48. The County Judge is authorized to sign the agreement on behalf of the Court.

— Drop from the agenda item #7-'Consider condemning one piece of property for right-of-way with regards to FM 3427.

2923 On the motion by Crowell, second by Mizell, the Court set June 10, 1986 as the date to meet with Dept. Heads regarding the Budget for Fiscal Yr. 1986-87.

2924 On the motion by Grimes, second by Lyon, the Court accepted the first road inspection at Equestrain Estates, Pct. 2

2925 On the motion by Grimes, second by Lyon, the Court accepted the second road inspection of Grande Verde, Phase II, Pct# 2. Court to notify Mr. Veldman of its action.

2926 On the motion by Lyon, second by Crowell, the Court approved line-item budget transfers.

— Regarding the second road inspection on 5-6-86 of a county road beginning at Kaufman-Hunt Co. line to Merino residence: No action required until the road is brought up to Co. specs.

2927 On the motion by Crowell, second by Lyon, the Court approved the United Telephone easement request in Pct. 4

2928 On the motion by Lyon, second by Crowell, the Court approved the Accounts Payable.

2929 On the motion by Grimes, second by Crowell, the Court removed Dorie Burke from the Sheriffs Dept. and added Karla Pierce, \$1,100 per mmo. Both effective 5/1/86.
