REGULAR SESSION  
JULY 14, 1986

The Hunt Co. Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with Judge Green presiding & Commissioners Crowell & Lyon present. Unless noted, in all votes of AYE, Judge Green cast an AYE vote. Opening prayer was given by Mike Crowell. Minutes were approved with the noted correction.

OLD BUSINESS:

**2953** On the motion by Lyon, second by Crowell, the Court unanimously approved the bid of Greenville Chrysler-Plymouth for a 1987 Sheriff Dept. automobile. Low bid price \$10,844.43

**2954** On the motion by Lyon, second by Crowell, the Court approved the easement request of Continental Telephone of TX in Pct. 2

NEW BUSINESS:

— The Public Hearing on the proposed budget for Revenue Sharing for FY 86-87 was held. Judge Green opened the hearing & the Court heard from members of the audience. Hearing was then closed.

— Request for final plat approval for Buena Vista Estates-Gerald Pickering: OLD BUSINESS next meeting.

**2955** On the motion by Lyon, second by Crowell, the final plat approval on Greenwolfe Acres, Pct #1-Bob Adams was approved.

**2956** On the motion by Lyon, second by Crowell, the Court approved the Hickory Creek Water Supply Corp. resolution regarding water lines as presented by their attorney, Randy Hullett.

**2957** The Court heard from Joe Weis regarding the item 'Interpret the provisions of the Oak Creek Country Club Lease'. After also hearing from Co. Atty Russell Brooks, a motion was made by Johnnie Lyon to amend the lease to insure that the County owns the permanent improvements made. This motion died for lack of a second.

— The Court heard from Ray Rager regarding the rocking of a public road in Pct. 2. This item will be considered under OLD BUSINESS at the next meeting.

— Several bids were received for road materials. The Court agreed to study the bids and make a decision under OLD BUSINESS at the next meeting.

— No bids were received on the removal of buildings on FM 3427. The Court agreed that the County would remove the buildings.

— County Extension Office regarding Fire Ant poison: OLD BUSINESS next meeting.

— The Court will take up the item regarding the removal of the wall partition from the office of JP John Willeford under OLD BUSINESS at the next meeting.

— The Court heard from Steve Ramsey regarding County liability insurance on vehicles. No action was required today.

— The Court heard from the Co. Treasurer regarding a separate office and extra help. The Court will take the item up again on August 11th at its regular meeting.

**2958** On the motion by Crowell, second by Lyon, the Court passed a resolution supporting East Texas State University.

**2959** On the motion by Crowell, second by Lyon, the Court voted to allow the Co. Auditor to advertise for proposals on computer services.

**2960** On the motion by Crowell, second by Lyon, the Court voted to amend the employees manual regarding WORKERS COMPENSATION per request of the County Auditor.

— Regarding 'Consider revision to be added to Employee Manual with regard to reimbursement of expenses' this will be considered under OLD BUSINESS at the next meeting.

— Regarding 'Consider adding AT&T Telephone System to Criminal Justice Center' this item will be considered under OLD BUSINESS at the next meeting.

**2961** On the motion by Lyon, second by Crowell, the Court granted the easement request of Continental Telephone Co. of TX. in Pct. 2.

**2962** On the motion by Crowell, second by Lyon, the Accounts Payable were approved.

Co. Auditor--Remove Gayle McCollum effective 6/30/86.

Co. Clerk--Remove Geneva Compton effect. 6/16/86. Place Laura Baker on medical leave from 6/16/86 thru 8/31/86. Move Barbara <sup>Lyday</sup> from R-4 to R-8; Betty Pruitt from R-3 to R-4; & Coy Green from R-1 to R-3 (all effective 6/16/86).

Pct. #4--Remove Curtis McVay effect. 7/15/86. Move Roy Dawson to Foreman (R-10); Earnest Henry to Bridge Foreman (R-7); John Riffle & Richard Newsome to R-6 (all effect. 7-15-86).

**2963** All personnel & payroll changes were approved on the motion by Crowell, second by Lyon.


