

REGULAR SESSION  
AUGUST 11, 1986

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present except for Mike Crowell. Judge Green presided. Invocation was given by Jimmy Hamilton. Minutes of the previous meetings were approved with correction as noted.

OLD BUSINESS:

**2981** The Court agreed to drop from the agenda discussion of the computer proposals that were submitted. Then, on the motion by Henry Grimes, second by John Mizell, the Court unanimously approved for the Auditor to advertise for bids or proposals for a computer consultant regarding computer services for the Courthouse.

—— 'Consider AT&T Telephone System for Criminal Justice Center'--OLD BUSINESS NEXT MEETING.

—— It was agreed upon by the Court that the partition to be removed in Judge Willeford's Office can be done at no cost to the County & requires no Court action.

—— 'Consider election judges & alternates & approval of polling places for the Nov. General Election'--OLD BUSINESS NEXT MEETING.

NEW BUSINESS:

**2982** On the motion by Grimes, second by Johnnie Lyon, the Court voted unanimously to allow the following tax discount: 3% in October; 2% in November; 1% in December 1986.

**2983** The request for approval of replat on Upchurch Estates in Pct. 3--Earnest & Gena Upchurch was granted on the motion by John Mizell, second by Grimes.

**2984** The request for approval of replat on Harold Morris Farms in Pct 3--Harold Morris was granted on the motion by Mizell, second by Lyon.

**2985** On the motion by Grimes, second by Mizell, the Court accepted the Environmental Health Service Agreement with the City of Quinlan & the City of West Tawakoni. The City of Quinlan agreement is subject to Quinlan City Council approval. The motion also calls for both cities to pay \$10.00 to the County for each permit issued. The County Judge is authorized to sign the Quinlan agreement.

—— The Court heard from Jim Davenport regarding the Constable position in Pct 3.

**2986** On the motion by Lyon, second by Grimes, the Court approved the request of Continental Telephone of TX. to locate lines on the County road in Pct. 1.

—— The Court heard from the County Treasurer requesting a separate office & extra help. These requests will be considered in the upcoming budget.

**2987** On the motion by Mizell, second by Grimes, the Court approved line-item transfers in the budget.

—— For a matter of record, the Texas Center For the Judiciary, Inc. advised the County that J.W. "Bill" Green has completed the required hours of judicial education for 1986.

**2988** On the motion by Grimes, second by Lyon, the Accounts Payable were approved.




