

COMMISSIONERS COURT MEETING

October 27, 1986

The Hunt County Commissioners Court met in Regular Session Monday, October 27, 1986 at 10:00 A. M. in the Commissioners Courtroom, with all members present and Judge Green presiding. Invocation was given by Judge Green.

3049 On the motion by Commissioner Lyon, second by Henry Grimes the Court unanimously accepted the low bid from Holman-Bennett-Phillips Co., on two new motor graders for Pct. 1. Total bid was 96,900.00

3050 A Resolution honoring Henry Lee Grimes as President of the State Association of County Judges and Commissioners was adopted on the motion by Johnnie Lyon, second by Mike Crowell.

— J. C. Tinsley with the Upper Sabine Hereford Assoc. discussed equipment located at the Hunt County Fair grounds. Judge Green noted that he was against the contract. Mr. Tinsley has requested some protection for use of equipment. Co. Attorney will look into this.

3051 On the motion by Lyon, second by Crowell the Court unanimously approved the appointment of Lucy Gibson as Director to the Child Welfare Board. The appointment of a second Director will be under old business at next meeting.

3052 County Clerk Jimmy P. Hamilton confirmed changes in Election officials and Polling places for the November 4, Election. Changes were unanimously approved on the motion by Mizell, second by Crowell.

3053 The Preliminary Plat on Olde English Acres in Pct. 2, was unanimously approved on the motion by Grimes, second by Lyon.

3054 On the motion by John Mizell, second by Crowell the Court unanimously approved the final plat of Greenbelle Acres in Pct. 3.

3055 The Final Plat of High Hollows, Phase 2, section B in Pct. 3 was unanimously approved on the motion by Mizell, second by Grimes.

3056 A letter from Texas Water Commission was discussed regarding Con-dor Pipeline Co. On the motion by Commissioner Grimes, second by Crowell letter notification was accepted unanimously.

3057 On the motion by Lyon, second by Grimes line locations for Continental Telephone Co. on County road in Pct. 1, was unanimously approved.

— There was a request from Family Services Center regarding M/H M/R Center for Hunt Co. This will be reviewed and put on next agenda, old business.

3058 On the motion by Mizell, second by Crowell the Court authorized Auditor Bennett to advertise for four new cars for the Sheriff's Office.

3059 The Court unanimously approved for Auditor Bennett to advertise for bids for insect and rodent control for the Courthouse and the Criminal Justice Center by the motion of Grimes second by Lyon.

3060 The accounts payable were unanimously approved on the motion by Lyon, second by Grimes.

3061 The Court approved a payroll change in the Tax Office, to add Deborah Hodge part time at 4.00 an hour, on the motion by Mizell, second by Grimes. All voted aye.

Court recessed until 1:30 P.M.

Court resumed at 1:50 P.M.

3062 The Court approved a Resolution to amend the Hunt County Road Specifications with two changes to be made on date and paragraph 5 concerning Bond. This was unanimously approved on the motion by Crowell, second by Lyon. This is to permit Citizens to contract. Const.
