REGULAR SESSION
DECEMBER 22, 1986

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present & Judge Green presiding. Opening Prayer was given by Jimmy Hamilton. Minutes of the previous meeting were approved with correction on # 3092.

OLD BUSINESS:

- Renewal of parking lot contract (East of Courthouse): OLD BUSINESS next meeting.
- Request of preliminary plat approval, Highway 66 Estates, Pct. 2—Bob Quinn: OLD BUSINESS next meeting.

NEW BUSINESS:

3101 On the motion by Grimes, second by Crowell, the Court voted 3-1 to accept the dedication of road & Quitclaim Deed from Robert L. Jordan to Hunt Co. Instruments to be filed in the Deed Records. This is a 50ft. wide road in the Equestrain Estates (Pct. 2). The Court accepts the road for ownership purposes only (not maintenance) & is subject to final inspection in May of 1987. FOR: Grimes, Crowell, Mizell. Opposed: Lyon. Motion carries.

3102 On the motion by Grimes, second by Crowell, the Court approved the final plat for Bethel Acres—Pct. 2: Jerry Wisdom.

3105 On the motion by Crowell, second by Grimes, the Court granted permission to United Telephone Co. of TX. to locate line on a County road in Pct. 4.

3106 On the motion by Grimes, second by Lyon, the Court approved the Accounts Payable.
