REGULAR SESSION
JANUARY 12, 1987

The 1987 term of the Hunt County Commissioners Court was called to order at 10:00 am in the Commissioners Courtroom by newly-elected County Judge Mike Farris. Newly-elected Commissioners Henry Hensley, Pct. 2 & Allen Martin, Pct. 4 were present; as well as Commissioners Johnnie Lyon, Pct. 1 & John Mizell, Pct. 3.

Opening Prayer was given by Judge Farris. Minutes of the previous meeting were approved as read.

OLD BUSINESS:

3108 On the motion by Lyon, second by Mizell, the Court awarded the bid for metal for bridges to Barnhardt's Steel Company.

Request for preliminary plat approval on Highway 66 Estates, Pct. 2-Bob Quinn:

The Court heard from Janet Moore concerning road & bridge conditions in Pct. 3. Ms. Moore to deal with Commissioner Mizell.

3111 On the motion by Lyon, second by Hensley, the Court approved the Bonds for Officials, (names & amounts are on file in the Auditors Office).

3112 On the motion by Martin, second by Hensley, the Court approved storage space on the 5th floor of the Courthouse for the County Attorney to store records.

Request for final plat approval on Bear Hill Acres, Pct 2-Johnny Barrow: Withdraw from agenda.

Request for final plat approval on Meadowlark Acres, Pct 2-Ray Poole: OLD BUSINESS next meeting.

3113 On the motion by Mizell, second by Lyon, the accounts payable were approved.


Tax Office: Add Patricia Sprague, R-1, effective 1/12/87.
