REGULAR SESSION
April 27, 1987

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present & Judge Farris presiding. Opening Prayer was given by Jimmy Hamilton. Minutes of the previous meeting were approved as read. There was no OLD BUSINESS.

NEW BUSINESS:

3192 The Court heard from Judge Joe Leonard regarding carpet and curtains or mini blinds for the County Court at Law Courtroom. On the motion by Henry Hensley, second by John Mizell, the Court approved expenditures for carpet and blinds with Judge Leonard to make the decision on the type of carpet. The funds are to come out of the Courthouse Renovation Account with a \$1,700 ceiling set for the total project. Unanimous vote.

3193 On the motion by Mizell, second by Allen Martin, the Court passed & signed a Court Order that taxes that remain delinquent on July 1st incur an additional penalty in the amount of 15% of the amount of taxes, penalty & Interest due, to defray costs of collection incurred pursuant to Texas Property Tax Code Sec. 33.07. Unanimous vote.

3194 On the motion by Hensley, second by Mizell, the Court authorized the Auditor to advertise for a track-loader tractor, Precinct #4.

3195 On the motion by Jonnie Lyon, second by Mizell, the Court voted 3-1 to approve the budget amendments & line-item transfers. FOR: Martin, Mizell, Lyon. Opposed: Hensley, Motion Carries.

— The Court heard from Jerry Jobe regarding limited late night opening for private clubs outside incorporated areas. A motion was made by Henry Hensley to extend by one hour the time that these clubs can stay open on Thursday, Friday & Saturday nights. This motion died for lack of a second.

3196 On the motion by Hensley, second by Martin, the Court authorized the County Auditor to advertise for bids for (1) Cracked road oil & (2) galvanized corrugated metal pipe & metal sheets.

3197 On the motion by Lyon, second by Hensley, the Court approved the request of the Co. Auditor for an additional telephone and line for the Auditor's Office. Unanimous vote. Commissioner Hensley offered an amendment to the motion which would make the purchase subject to a purchase order system being initiated. This motion died for lack of a second.

— 'Consider engaging outside auditing firm for annual audit fiscal year ending September 30, 1986': OLD BUSINESS next meeting.

3198 The Accounts Payable were approved on the motion by Lyon, second by Martin.

3199 On the motion by Lyon, second by Hensley, the Court accepted the resignation of Constable Tim Monk, Pct #4 , effective 4/20/87.

3200 On the motion by Lyon, second by Mizell, the following Personnel/Payroll change was made: In Pct#3, remove Claudis Williams effective 4/15/87.

3201 On the motion by Hensley, second by Lyon, the Court approved changing the Court date from Monday, May 25th to Tuesday, May 26th due to the Memorial Day Holiday.

Court Adjourned. Minutes approved this 11th day of May, 1987.
