MAY 11, 1987

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present & Judge Farris presiding. Opening Prayer was given by John Mizell. Minutes of the previous meetings were approved as read.

**3203** Judge Farris informed the Court that he had two proposals for outside auditors & that a third firm was interested in submitting a proposal. On the motion by Martin, second by Johnnie Lyon, the Court agreed to set a deadline for receiving proposals to 5 pm, Monday May 18, 1987. **3207** On the motion by Mizell, second by Martin, the Court approved the preliminary plat on Oak Trails, Pct #3 Jerry Wisdom.

**3208** On the motion by Hensley, second by Lyon, the Court authorized the Auditor to advertise for two 2-ton trucks in Pct. 2.

**3209** On the motion by Lyon, second by Hensley, the Accounts Payable were approved.

a study meeting after meeting with the Co. Attorney on 5/22/87.


**3211** The Court went into executive session to consider the appointment of a Constable
