January 25, 1988

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom. All members were present & Judge Mike Farris presided. Minutes of the previous meeting were approved with noted corrections.

OLD BUSINESS:

— The Court took no action on bids for copier machines for the third & fourth floors of the Courthouse. The Court will consider bids under OLD BUSINESS next meeting.

NEW BUSINESS:

— 'Consider request by Hunt County Appraisal District to ratify the action of the Board of Directors in purchasing and constructing building now in use - Chief Appraiser, Joe Davis' - the Court will take the item up on Friday, January 29th at 1:30 pm in a Special Session.

**3464** On the motion by Lyon second by Hensley, the Court approved a tax refund in the amount of \$1,044.69 to Norman Allen Martin of Garland, Tx. This at the request of Tax Assessor-Collector Joyce Barrow.

**3465** On the motion by Martin, second by Mizell, the Court authorized the Auditor to pay employees' travel amounts on the 15th day of each month, as a part of the payroll check.

**3466** On the motion by Mizell, second by Martin, the Court approved the request made by Farmers Electric Cooperative, Inc. to locate a line on a public roadway in Pct.3.

**3467** On the motion by Hensley, second by Mizell, the Court authorized the Auditor to advertise for bids on

- (1) New tree limb shredder machine, Pct.2
- (2) New and/or used 10 to 12 yard air belly dump trailer, Pct.2
- (3) Hauling of rock to Pct.2

**3468** On the motion by Hensley, second by Martin, the Court authorized the Auditor to advertise for gas and/or diesel for County precinct barns and Sheriff's Department.

**3469** On the motion by Mizell, second by Lyon, the Court authorized the Auditor to advertise for bids for the Hunt County Depository.

**3470** On the motion by Lyon, second by Hensley, the Accounts Payable were approved.
