

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present & Judge Farris presiding. Opening Prayer was given by John Mizell. Minutes of the previous meetings were approved with noted additions.

OLD BUSINESS:

3521 On the motion by John Mizell, second by Johnnie Lyon, the Court unanimously approved a resolution authorizing the County Judge of Hunt County, Texas, to execute an agreement regarding participation by Hunt County in the multi - agency special investigative task force and setting forth the operation guidelines. This action taken at the request of the County Attorney.

NEW BUSINESS:

— The Court heard from Lee Lewin concerning industry and mini-mall tax abatement for Southern Hunt County.

— 'Consider clerical service for the Health Department - Jay Caudle: OLD BUSINESS next meeting.

— The Court received information regarding request to re-open a road in Pct.2 - Carl Daniel and Dan Farr. If necessary, the Court will set a special meeting at a later date.

— The Court received information from Lon Akin regarding the closing of a road in Pct.#2.

Opening of bids resulted in the following action:

3522 On the motion by Martin, second by Mizell, the Court accepted the bid from Crossroads Business Machines for typewriter maintenance at a cost of \$34.50 per machine.

3523 On the motion by Hensley, second by Martin, the Court accepted the bid from Ken Parker Service for maintenance on the air conditioners at the Criminal Justice Center at a total cost of \$1950 to be paid quarterly following quarterly inspections.

— Commissioner Lyon made a motion not to approve at the present time the preliminary plat of North Greenville Ranchettes in Pct #1. This motion died for lack of a second. The Court agreed to postpone action until a later date in order to receive some clarifications on the plat.

— Drop from the agenda item #7 'Consider final plat of Pecan Valley in precinct #3.

— For the record: Judge Farris has appointed Bill Turner, Jerry Kirchman, and Julia Anderson to the North Central Texas Housing Finance Corp. No action was necessary by the Court.

3524 On the motion by Hensley, second by Mizell, the Court approved the request from Farmers Electric Cooperative to locate line across a public roadway in Pct.2 as noted on the map submitted with the request.

— The Court agreed to meet Thursday, March 31st at 9:30 am, weather permitting, for the installation of the first county road - number sign.

3525 On the motion by Hensley, second by Martin, the Court denied the 'Centel Telephone of Texas, Inc. notification of telephone construction' in its present form.

3526 On the motion by Lyon, second by Mizell, the accounts payable were unanimously approved.


