

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present and Judge Mike Farris presiding. Minutes of the previous meeting were approved as read.

OLD BUSINESS:

**3528** On the motion by Allen Martin, second by Johnnie Lyon, the Court approved the request of Jay Caudle for \$8,278.50 to be appropriated for clerical help in the Health Dept. subject to a budget amendment, and provided it does not violate the terms of the Health Dept. contract with Hunt County. Unanimous vote.

NEW BUSINESS:

**3529** On the motion by John Mizell, second by Henry Hensley, the Court set the date of May 2, 1988 at 10:00 am in the Commissioners Courtroom for the purpose of a public hearing on a county - wide food service ordinance (H.B. 2125). This action taken at the request of Richard Briley with the Health Dept.

**3530** On the motion by Hensley, second by Martin, the Court accepted the bid from 3M / Business Products Sales Center, Grand Prairie, Tx. for a microfilm camera to be used by the District Clerk. Bid amount \$7,300.68 , payable in 48 monthly installments of \$178.14 or \$534.41 per quarter.

**3531** On the motion by Hensley, second by Martin, the Court approved the numbers assigned to county roads for the road mapping system. The numbers were designated by each Commissioner for his precinct. The numbers will be placed on a mylar map for reproduction purposes.

**3532** On the motion by Mizell, second by Hensley, the Court set the date of April 23, 1988, for a public auction of surplus county equipment to be held in Lone Oak.

**3533** On the motion by Hensley, second by Mizell, the Court authorized the Auditor to advertise for proposals regarding a sub-station on county property in Quinlan (next door to City Hall).

**3534** On the motion by Mizell, second by Martin, the Court authorized the Auditor to advertise for road oil for the precincts.

**3535** On the motion by Mizell, second by Hensley, the Court approved the notification of telephone construction in Precincts 2&3 from Contel Telephone of Texas, Inc. with an addition made by the Court stating that Hunt County assumes no financial liability for damage done to lines or pipes as a result of maintenance performed on the right-of-way. Also, a change in paragraph #1 that cable shall be buried not less than 36" (rather than 24") and in paragraph #3 that hard-surfaced and gravel roads will be bored and dirt roads <sup>may</sup> ~~will~~ be plowed.

**3537** On the motion by Martin, second by Lyon, the accounts payable were approved.
