

Regular Session
April 25, 1988

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present and Judge Farris presiding. Minutes of the previous meeting were approved as read.

OLD BUSINESS:

3539 On the motion by Allen Martin, second by John Mizell, the Court ordered that taxes that remain delinquent on July 1 of the year in which they become delinquent incur an additional penalty in the amount of 15 % of the amount of taxes, penalty and interest due, to defray the cost of collection incurred pursuant to Texas Property Tax Code Section 6.30. The Court further ordered that the Hunt County Tax Assessor/Collector deliver a notice of delinquency and of the penalty to the property owner at least 30 and not more than 60 days before July 1 pursuant to Texas Property Tax Code Section 33.07 (d).
Unanimous Vote.

3540 On the motion by Johnnie Lyon, second by Martin, the Court gave permission to the Tax Assessor/Collector to contact other taxing entities to collect their property taxes.

3541 On the motion by Mizell, second by Martin, the Court gave permission to the Tax Assessor/Collector to rent a larger printer from Software Group at a cost of \$580 per month.

NEW BUSINESS:

—— Discuss request regarding the Hunt County Fair Parade- Charles Austin: OLD BUSINESS next meeting.

3542 On the motion by Mizell, second by Martin, the Court approved the preliminary plat on Mc Grew Creek Estates, Pct. #3.

3543 On the motion by Mizell, second by Henry Hensley, the Court voted 3-1 to approve the preliminary plat on North Greenville Ranchettes, Pct.#1. For: Mizell, Martin, Hensley. Against: Lyon. Motion carries.

3544 On the motion by Hensley, second by Mizell, the Court authorized the Auditor to advertise for proposals for an in-house computer system.

—— Consider adoption of mandatory physical examination for all new employees: OLD BUSINESS next meeting.

—— Consider road access to private property - Henry Hensley: drop from the agenda.

3545 On the motion by Lyon, second by Martin, the Court authorized the Auditor to advertise for bids on (1) steel culverts and (2) Hot and cold asphalt mix.

3546 On the motion by Mizell, second by Hensley, the Court approved the request from Farmers Electric Cooperative to locate a line on public roadways in pcts # 2 & 3 as shown on the maps accompanying the requests.

3547 On the motion by Martin, second by Lyon, the accounts payable were approved.
