REGULAR SESSION  
APRIL 12, 1993

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with Judge Mike Farris presiding. All Commissioners were present except Commissioner Hensley. Minutes of the previous meeting were approved as read.

OLD BUSINESS:

**5149** On the motion by Allen Martin, second by Johnnie Lyon, the Court accepted all bids for gasoline and diesel fuel. Bids on file in Auditor's Office.

**5150** On the motion by Judge Farris, second by Martin, the Court approved a resolution in support of local management for TX. Dept. of Aging case management and benefits counseling.

Discussion regarding security plans proposed by the Courthouse Security Committee: Bob Thomas told the Court that a \$2,000 donation had allowed for the purchase of some security devices. The Court agreed to consider the item further during the upcoming budget hearings.

The Court agreed, on a non-vote, to allow Drug Free Greenville to use the hallways and restrooms on the first floor of the Courthouse from 7 am to noon on May 1, 1993 for the 1993 Walk-a-Thon.

**5151** On the motion by Judge Farris, second by Martin, the Court agreed to participate in a Commissioners Forum to be sponsored by the Greenville Chamber of Commerce, provided that a mutually-agreeable date can be found. FOR: Farris, Martin, Jim Hart. AGAINST: None. ABSTAINED: Lyon. Motion Carries.

**5152** On the motion by Hart, second by Martin, the Court agreed to joining the Conference of Urban Counties for one year at a cost of \$843.

NEW BUSINESS:

The Court received one bid for a used sheep foot vibratory compactor for Precinct 3. The bid was from Mega Equipment Co. of Irving, TX. The Court will consider final action under OLD BUSINESS next meeting.

'Discuss and consider approval of a request from GTE for constructing a buried telephone plant facility along the right-of-way of County Road 2240--Henry Hensley, Commissioner Precinct 2':

**5154** On the motion by Martin, second by Hart, the Court agreed to advertise for and hold a public hearing on April 26, 1993 at 9:30 am regarding traffic regulations on certain county roads.

**5155** On the motion by Judge Farris, second by Martin, the accounts payable were approved.


**5156** On the motion by Judge Farris, second by Martin, the line-item budget transfers were approved.


