JANUARY 23, 1995

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all Commissioners present and County Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as read.

— 'Discuss, consider, and possibly take action on extending maintenance contract between Hunt County and E-Tex regarding air conditioning and heating at Annex Bldg.--Dixon Latham': Drop from the agenda.

— 'Discuss, consider, and possibly take action on relocation of Juvenile Probation administrative office--Co. Judge Bobbitt': Judge Bobbitt stated that Rep. Oakley has moved out of the space in the Annex Building and that the Judge and John Conatser would form a plan to be brought before the Court. In the meantime, the item will be dropped from the agenda.
