REGULAR SESSION
MARCH 13, 1995

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all Commissioners present. Judge Bobbitt was absent. Commissioner Johnnie Lyon presided. Minutes of the previous meeting were approved as read.

There was no Old Business.

NEW BUSINESS:

5836 On the motion by Ralph Green, second by Jim Hart, the Court disapproved amending preliminary plat for Lots 3 & 4 in the Hoffman Estates subdivision as submitted by Larry Maas.

5837 On the motion by Green, second by Allen Martin, the Court approved the budget transfer request regarding rent for office space for Constable Cullen Smith with the stipulation that a contract will be drawn up on the rental agreement.

5838 On the motion by Hart, second by Green, the Court accepted the following bids on the resale of properties having Sheriff's deeds: R25846/101430--Jerry & Dorothy Womack--\$60,116. R30594/108209--Board of Development, City of Greenville--\$40,750.

5839 On the motion by Hart, second by Martin, the Court approved the final plat for the Maloy Oaks subdivision.

5840 On the motion by Green, second by Lyon, the Court appointed Allen Martin and Jim Hart to fill vacancies on the ^{COMMERCE JPH} Joint Airport Zoning Board.

5841 On the motion by Hart, second by Martin, the Court adopted a Public Participation Form to be completed by participants who wish to address the Commissioners Court.

5842 On the motion by Green, second by Hart, the Court voted to approve an ordinance regulating and licensing commercial trash haulers, establishing a review board, and providing a penalty, effective 5-15-95.
FOR: Green, Hart, Martin. AGAINST: None. ABSTAINED: Lyon. Motion Carries.

— Regarding the item 'Discuss, consider, and possibly take action on request to allow Safe Tire Disposal Corp. to furnish enclosed trailer for tire disposal--Commissioner Jim Hart': After hearing from Toby Phillips, Phillips Tire Company, the item was dropped from the agenda.

5843 On the motion by Martin, second by Hart, the Court approved the request of Loss Control Coordinator Marilyn Jacobs to have ergonomic training for back injury prevention for Road & Bridge, Office Workers, & Maintenance Dept.

5844 On the motion by Hart, second by Martin, the Court approved (with liability disclaimer) the request from FEC Electric to construct power distribution facilities over Co. Road 3202.

5845 On the motion by Hart, second by Martin, the Court passed a resolution opposing any state legislation that provides for state regulation or oversight of local government worker's compensation pool.

5846 On the motion by Martin, second by Green, the Court named Jim Hart as the primary point of contact for the Litter Abatement Officer and Judge Bobbitt as the secondary point of contact.

— Hear & Discuss Reports--The Court heard from Jack Gibson of Lone Oak concerning the problem of trash dumping in the County.

5847 On the motion by Hart, second by Martin, the accounts payable were approved.

5848 On the motion by Martin, second by Green, the line-item budget transfers were approved.
