REGULAR SESSION
JULY 24, 1995

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with Commissioner Johnnie Lyon presiding and all Commissioners present. Minutes of the previous meetings were approved as read.

OLD BUSINESS:

— 'Possibly take action on establishing a county-wide speed limit on all county-maintained roads--
Commissioner Hart': OLD BUSINESS next meeting.

5977 On the motion by Ralph Green, second by Jim Hart, the Court approved the purchase of a 1995 Jeep Cherokee from Jackson Motors, Greenville Texas, for the Health & Safety Officer at a price of \$14,985.
Terms: \$1,000 down, balance due by October 7, 1995.

5978 On the motion by Hart, second by Allen Martin, the Court approved regulations regarding sexually-oriented businesses in Hunt County. The proposed regulation was modified by changing the distance requirements in Section 13 (A) from 1,000 feet to 1,500 feet and by changing the period of time in Section 5A from 60 to 90 days

NEW BUSINESS:

— 'Possibly take action on any items concerning the Courthouse renovation/restoration project': Received report from Dale Sellars. No action required.

5979 The Court received one bid for pickup trucks in Pcts. 1, 2, & 4. The bid was from Gober-Merrell Chevrolet, Sulphur Springs Texas. On the motion by Lyon, second by Martin, the Court accepted the bid for a 1995 Silverado Chevrolet extended-cab pickup at a price of \$21,060, less trade-in of \$5,000. Net price \$16,060.
The bid for trucks for Pcts. 2 & 4 will be reviewed and action on them considered under Old Business next meeting.

5980 On the motion by Hart, second by Lyon, the Court voted to exercise a one-year option on the contract for tax statements & notices with Laser Printers, Inc., San Antonio, TX. Bid price \$26,500.

5981 On the motion by Lyon, second by Martin, the Court rescinded the resolution on the resale of property account #R108581.

5982 On the motion by Green, second by Martin, the Court approved the bid on the resale of property account #R40189, from Jenny Moses for \$101.

5983 On the motion by Green, second by Martin, the Court voted to advertise for a Registered Sanitarian II to replace Jay Caudle who is retiring 8-31-95.

5984 Jay Caudle proposed that the Court increase the on-site sewage facility permit & licensing fees.
On the motion by Hart, second by Lyon, the Court voted to leave the fees at their current amount.

5985 On the motion by Lyon, second by Hart, the Court approved (with liability disclaimer) the request from Greenville Electric Utility System to construct a power line along CR 1064.

5986 On the motion by Martin, second by Green, the Court approved (with liability disclaimer) the request from United Telephone to bury cable along the right-of-way on CR 4507 & 4813 in Pct. 4.

— 'Approve consolidation of voting precincts for the Nov. 7, 1995 Constitutional Amendment Election & appoint election judges to serve in each consolidated precinct--Co. Clerk Jimmy Hamilton (TX Election Code, Sec. 32.003 & Sec. 42.008): Old Business next meeting.

5987 On the motion by Hart, second by Martin, the Court appointed the list of election judges and alternate judges for election year 1995-96 as submitted by Co. Clerk Jimmy Hamilton.

— 'Possibly take action on approving final plat for the Wall-View Estates, Section Three Subdivision in Pct. 3': Old Business next meeting.

— 'Hear from & possibly take action on Lancer Road (CR 4101) complaints from J.J. Harget': Drop from the agenda.

5988 On the motion by Lyon, second by Martin, the Court renewed the County Health Care Plan through TAC.

— 'Possibly take action on advertising for janitorial services & maintenance for the Courthouse, CJC, and Annex Bldg.--Commissioner Hart': Old Business next meeting.

5989 On the motion by Hart, second by Green, the Court approved the acceptance of Caddo Creek Road (.570 miles) into Pct. 3.

— Hear & discuss reports: Diane Terry named "Employee of the Month" for August.

5990 On the motion by Martin, second by Hart, the accounts payable were approved.

5991 On the motion by Green, second by Hart, the line-item budget transfers were approved.

There was no Executive Session. Court Adjourned.


