REGULAR SESSION
AUGUST 28, 1995

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present and Judge Joe Bobbitt presiding. Minutes of the previous meetings were approved as read.

OLD BUSINESS:

———— 'Possibly take action on computer service maintenance agreement for FY 95/96: Drop from the agenda.

6020 On the motion by Judge Bobbitt, second by Jim Hart, the Court voted to relocate the Co. Treasurer's Office to the second floor space formerly occupied by the County Commissioners. The Court will address the security measures to be taken by the move.

NEW BUSINESS:

———— 'Possibly take action on any items concerning the Courthouse renovation/restoration project':

No action necessary.

———— 'Possibly take action on request by Ray Ridings to waive penalties for delinquent taxes': The Court heard from James Faires, attorney, representing Mr. Ridings, who came requesting the Court to waive the 1982 & 1984 penalties. Based upon the recommendation of the County's tax attorney, on a non-vote the Court agreed to deny the request.

6021 On the motion by Johnnie Lyon, second by Ralph Green, the Court approved the collection contracts with the following taxing jurisdictions for the 1995 tax year: Bland, Boles, Caddo Mills, Campbell, Celeste, Commerce, Greenville, Lone Oak, & Quinlan ISDs and the cities of Caddo Mills, Celeste, Commerce, Greenville, Lone Oak, Quinlan, West Tawakoni, & Wolfe City, as well as the Hunt Memorial Hospital District.

6022 On the motion by Lyon, second by Allen Martin, the Court approved the following bids on properties having Sheriff's Deeds: R40189-Jenny Moses-\$101 and R42361-R.E. Willits-\$525.

6023 On the motion by Bobbitt, second by Lyon, the Court voted to set the proposed tax rate for FY 95-96 at 43.78¢ per \$100 valuation. FOR: Bobbitt, Lyon, Green, Martin. AGAINST: Hart. Motion Carries.

6024 Regarding the item 'Possibly take action on FEMA Flood Plain Program-Co. Judge Joe Bobbitt': The Court heard from Betty Williams, Bob Williamson, Patrick Hannan, Patty Hannan, Sandra Wiley, Jacque Murley, Judy Harris, and Howard Winans on the matter. On the motion by Bobbitt, second by Green, the Court voted to submit a resolution to comply with corrective actions necessary to remain in the FEMA Floodplain Management Program. FOR: Bobbitt, Green, Martin. AGAINST: Hart, Lyon. Motion Carries.

———— The Court heard from Linda Cannon, Sherry Ellenburg, & Glenda Lott concerning CO. RD. 2276.

No action taken.

6025 On the motion by Bobbitt, second by Martin, the Court approved the 1996 contract for public health services between TX. Dept. of Health, Hunt County, and the City of Greenville.

6026 On the motion by Green, second by Hart, the Court approved the preliminary plat for the Liberty Acres East subdivision and the final plat for the Liberty Acres West in Pct. 2 as submitted by Richard Merrington.

———— 'Possibly take action on approving final plat for the Camp Ranch Estates in Pct. 3-Richard Merrington':

6027 On the motion by Hart, second by Martin, the Court approved the final plat on Hideaway Estates Phase Two in Pct. 3, as submitted by Michael Heine.

6028 On the motion by Bobbitt, second by Lyon, the Court exercised a one-year option on the bid for uniform rentals from Aratex, Greenville TX.

6029 On the motion by Bobbitt, second by Green, the Court authorized the Auditor to advertise for proposals on fire alarm systems (minimum requirements).

6030 On the motion by Lyon, second by Martin, the Court approved a maintenance agreement with AT&T for the Legend telephone equipment at a cost of \$5,232.12.

6031 On the motion by Martin, second by Hart, the accounts payable were approved.

6032 On the motion by Green, second by Martin, the line-item budget transfers were approved.

SEPTEMBER 7, 1995




General Fund	\$.2309
