REGULAR SESSION  
SEPTEMBER 11, 1995

The Hunt County Commissioners Court met this day at 10:00 am in the Commissioners Courtroom with all members present and Judge Joe Bobbitt presiding. Minutes of the previous meetings were approved as read.

OLD BUSINESS:

**6034** On the motion by Jim Hart, second by Allen Martin, the Court approved the final plat for the Camp Ranch Estates subdivision in Pct. 3 as presented by Richard Merrington.

NEW BUSINESS:

\_\_\_\_\_ The Court discussed with Dale Sellars, Mid-Continental Restoration, two problems concerning the Courthouse renovation project. No formal action was taken by the Court.

\_\_\_\_\_ 'Possibly take action on approving final plat for Wall-View Estates subdivision in Pct. 3-Wayland Walker': OLD BUSINESS next meeting.

**6035** Regarding the item, 'Possibly take action on additional funding requirements for 1995 off-system bridge project-TXDOT': The Court heard from Mr. Robert Davis who said that Hunt County needed to pay \$23,402.10 (from Pct. 3) and \$3,610.69 (from Pct. 2) by September 15th. Following an Executive Session later in the day, on the motion by Bobbitt, second by Hart, the Court agreed to finance, out of the General Fund, the amount of \$23,402.10 (for Pct. 3) with Pct. 3 repaying the General Fund out of FY 95-96's budget, with T-Note interest applied. Precinct 2 will pay \$3,610.69 out of the FY 94-95 budget.

**6036** Joe Lilly came requesting that the Court approve the hiring of John Ludeke as an R.S. II in the Health Dept. A motion was made by Bobbitt, second by Ralph Green, to hire John Ludeke as an R.S. II at a salary of \$34,063.60 (incl. benefits). FOR: Bobbitt, Green. AGAINST: Johnnie Lyon, Hart, Martin. Motion Fails.

**6037** On the motion by Martin, second by Hart, the Court voted to approve a 'Notice Relating to Designation of Reinvestment Zone and Intention to Enter Into Tax Abatement Agreement' from the City of Commerce. FOR: Bobbitt, Martin, Green, Hart. AGAINST: Lyon. Motion Carries.

**6038** On the motion by Bobbitt, second by Martin, the Court voted to approve the County budget for FY 95-96 with anticipated total receipts of \$11,285,107 and estimated total expenditures of \$15,444,123. FOR: Bobbitt, Lyon, Green, Martin. AGAINST: Hart. Motion Carries.

**6039** On the motion by Bobbitt, second by Green, the Court voted to set the tax rate for FY 95-96 as follows:

**6041** On the motion by Martin, second by Green, the Court exercised a one-year option on radio maintenance. Bid on file in Auditor's Office.

— FOR THE RECORD: Johnnie Lyon, Ralph Green, Jim Hart, and Allen Martin have received 16 hours of Continuing Education credits.

— 'Possibly take action on security for the 354th Courtroom and the District Attorney's Office-- Duncan Thomas': Old Business next meeting.

— Hear & Discuss Reports: The Court heard from Fred Bernhardt, Mr. & Mrs. A.E. Whitten, Lynwood & Yvonne Lovelace, and Donna Chumley concerning Hunt County Road 2512. Then the Court was told by the County Auditor that the price of copy paper was going up from \$34.36 per case to \$37.95.

**6042** On the motion by Hart, second by Martin, the accounts payable were approved.

**6043** On the motion by Martin, second by Hart, the line-item budget transfers were approved.
